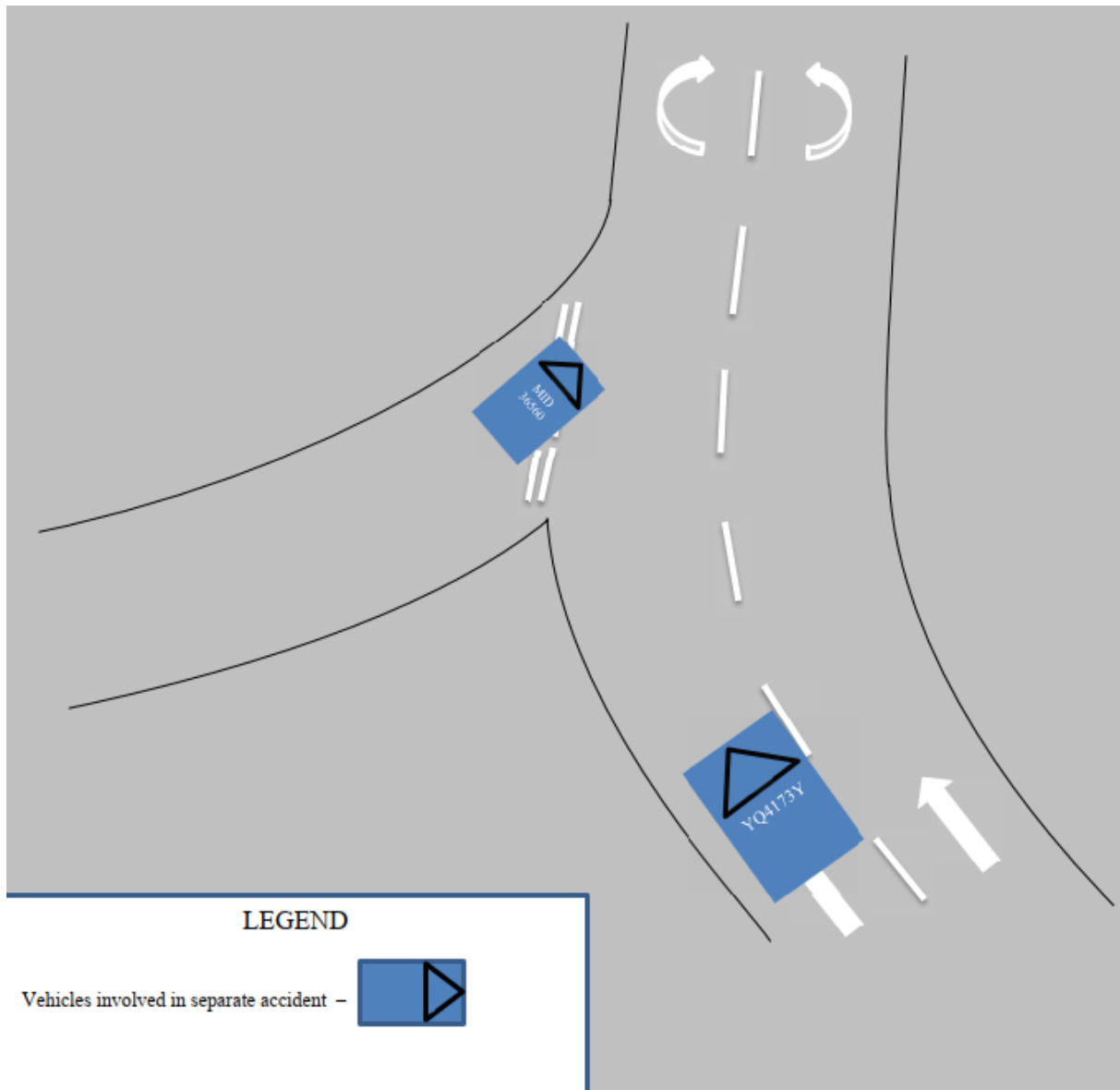

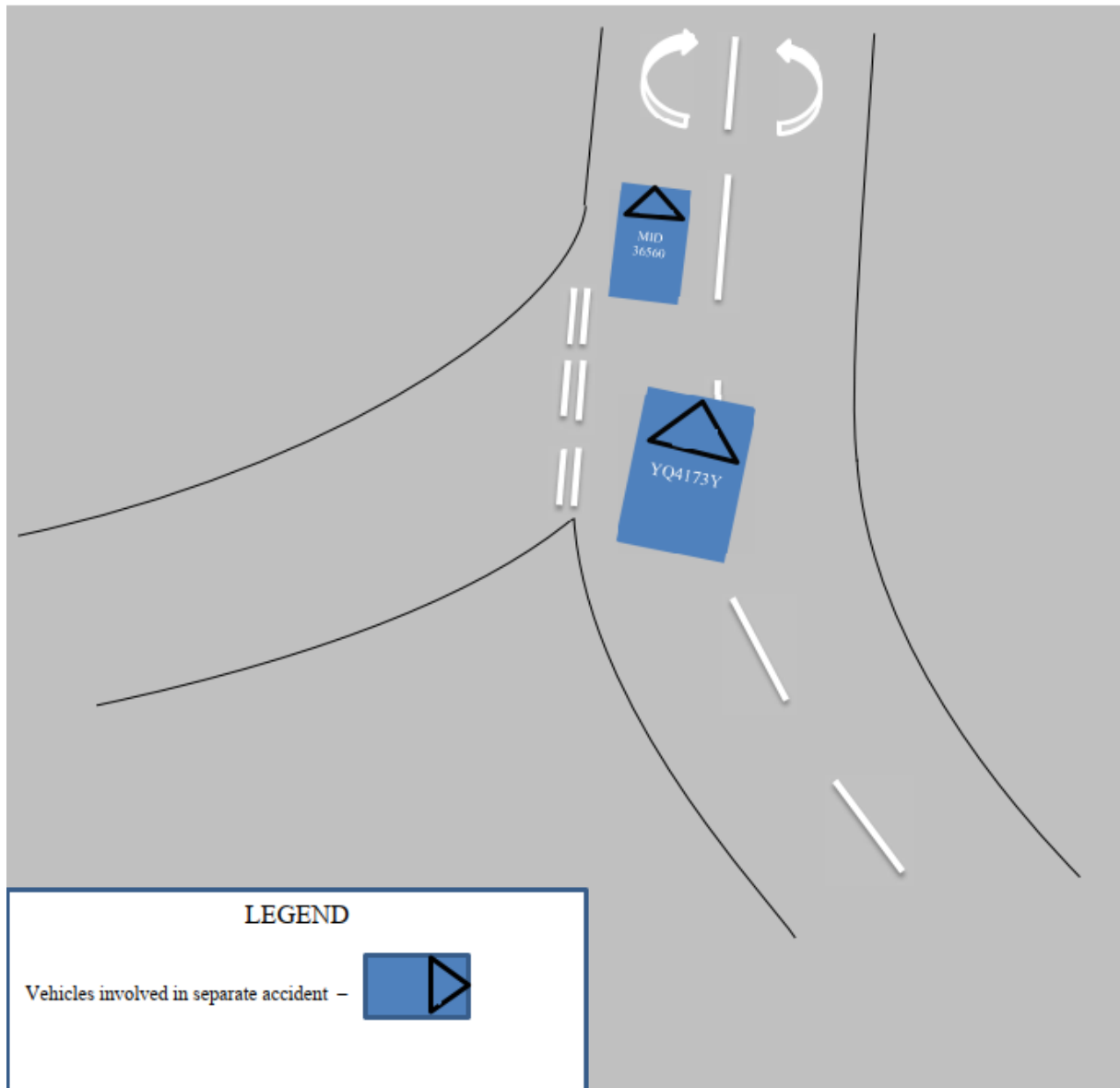

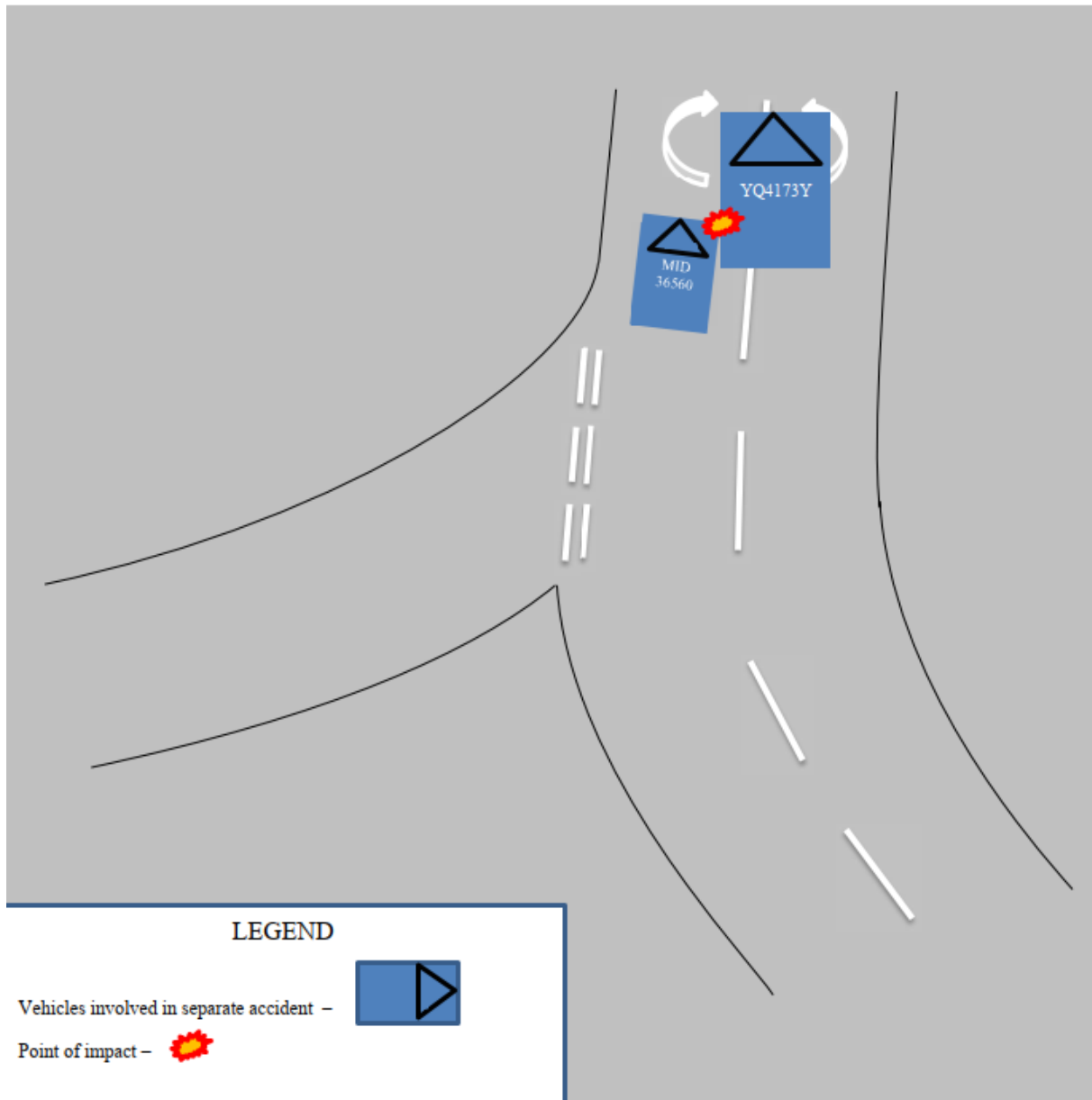

<p>I, T 5611, PTE GOH QING KAI was driving from Sungei Gedong Camp back to Sembawang Camp. While travelling along Jalan Bahar, I entered a slip road and was prepared to stop my vehicle when a black civilian vehicle was coming from the right side. My vehicle commander, 3SG ONG WEI HANG, instructed me to stop my vehicle and give way to the oncoming vehicles from the right. However, I did not stop my vehicle but slowed down instead to give way to the black civilian vehicle. I checked my right side before exiting the slip road and I turned onto the lane merge without noticing the oncoming white civilian lorry on the right. The lorry tried to steer right to avoid my vehicle but ended up grazing the right side of my vehicle. After noticing the lorry grazed my vehicle, I immediately stopped my vehicle to assess the situation.</p>

At around 1535hrs, the vehicle was turning from a slip road on Jalan Bahar onto KJE/PIE (Changi). I instructed my TO to stop at the give way line for the oncoming vehicles from the right as I saw there were vehicles ahead and a black civilian vehicle was nearing our vehicle. My TO heard my instruction but slowed down instead of stopping. After giving way to one civilian vehicle, my TO checked that his right side was clear and exited the slip road. I was focusing on giving way to the first black civilian vehicle ahead and did not notice the oncoming civilian lorry until after we exited the slip road.</p>

CONTINUATION OF REPORT

Brief Details.

A class 3 military vehicle (MID 36560) was travelling along Jalan Bahar while driving from Sungei Gedong Camp back to Sembawang Camp. The military vehicle entered a slip road that was turning onto KJE/PIE (towards Changi). The military vehicle slowed down to give way to oncoming vehicles from the right. After giving way to a black civilian vehicle, the driver checked the right side and assessed that it was clear to move off. The military vehicle then turned onto the lane merge without noticing an oncoming white civilian lorry (YQ4173Y) from the right. The white civilian lorry attempted to steer away from the military vehicle but ended up grazing the military vehicle.
