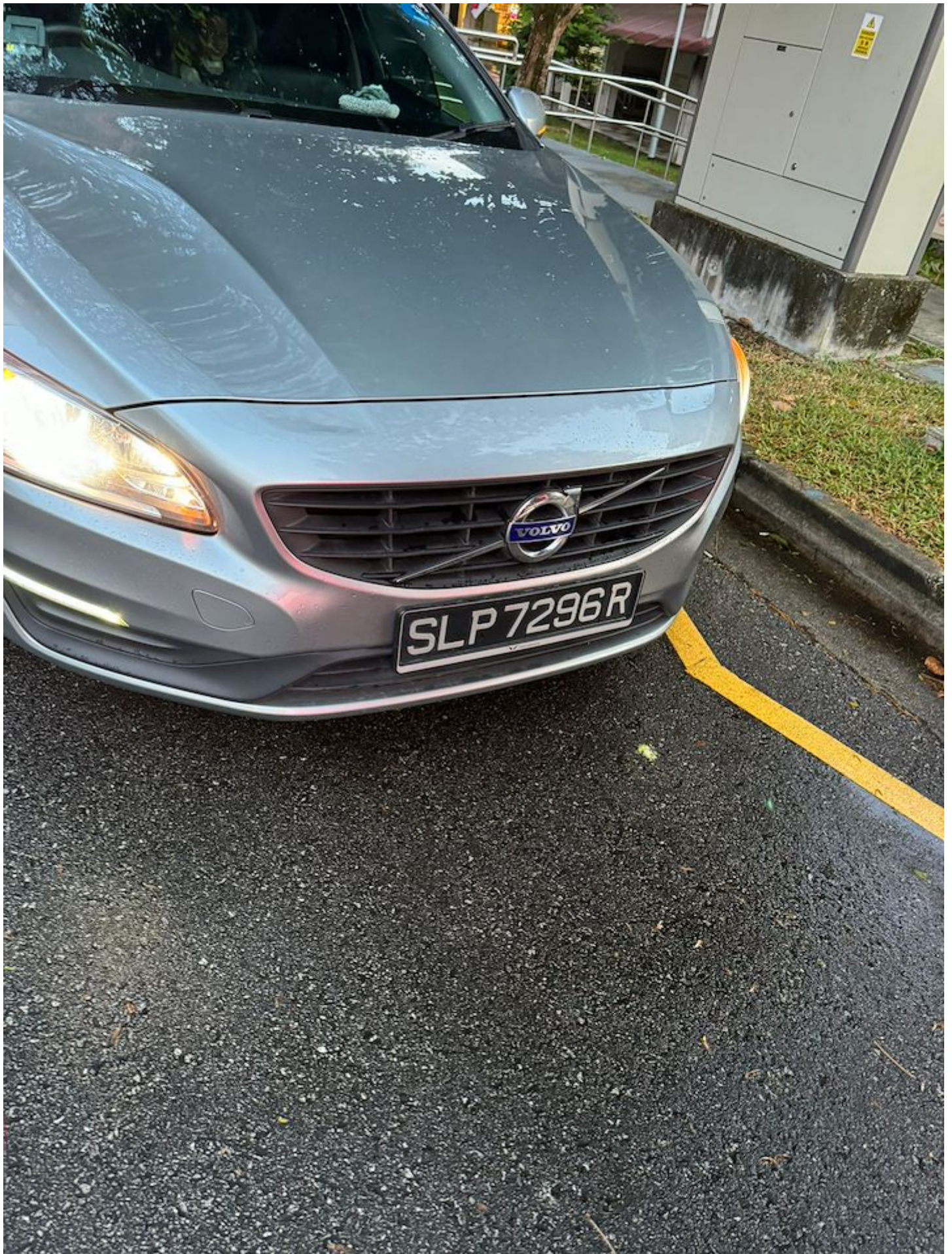

Brief Details.

On 8th August 2024, as usual, I fetched my daughter to school, CHIJ St Nicholas Girls' School with the registered vehicle, SMF7850G. After dropping her off at the school's gate, I exited Car Park No: A26 (Surface Car Park). Upon exiting the mentioned car park, traffic already started to build up on dual-way T-Junction road at 1.371874, 103.836638 (GPS Coordinates) demarked by an X-Junction Yellow-Box.

As the major Cross-Junction Traffic Light along Ang Mo Kio Ave 13, Ang Mo Kio Ave 4, and Mayflower Ave (around 1.373477, 103.837260 - GPS Coordinates) was red in the direction of drive, to the left (Mayflower - TE6 MRT Station) and the right (Kebun Baru Community Club), the traffic came to stand still. Knowing that the drivers who were exiting the car park had the right of way into the X-Junction Yellow-Box during such a situation, I made a slow left-handed turn in almost stagnant flowing traffic into the permitted X-Junction Yellow-Box; observed in my car VideoCam at 07:04:53 to 07:04:58. At 07:04:58, (Scene1.pdf) my vehicle came to a complete stop in between the first and second lane; where second lane was my intended lane of travel to move forward with the traffic.

The traffic light turned green to allow the vehicle to move again. At 07:05:06, the Chevrolet SUV before began to move and I started to inch out slowly to straighten my vehicle towards the desired lane. I was shocked to realise that a car, Volvo S40 - SLP7296R, brushed against my vehicle's right front section. I reviewed the car's Video Cam, and found out it was at 07:50:10 (Scene2.pdf).

It was a moving, congested road filled with vehicles and we could not stop in the middle of the road to find out if there were damages. Thus, we filtered to Mayflower Ave, next right-turn, and stopped at the side of the road to assess any damages. We debated on who had the right of way, but we could not come to an agreed terms. I requested an exchange of our
