### ACCIDENT INVOLVING SJF 7423S(OI) & SJY 1169R(TP) ON 02/03/2015

We refer to the above matter.

Third party driver reported that he was driving along Upper Thomson Road heading towards the junction of Jalan Todak. As he reached the junction, our insured turned into Jalan Todak without giving way (Traffic light was green in third party's favour) and resulted the accident.

Our insured driver reported that he was driving along Upper Thomson Road at the junction of Jalan Todak. He was turning into Jalan Todak with the green arrow light. In the midst of turning, third party came from his left and collided onto his car.

We have contacted our insured driver to verify the nature of accident. He confirmed that the traffic light is green in his favour. No evidence. He agreed to let insurance to settle the matter at best.

Both parties reported that traffic light was green in their favour. However there was no substantial evidence (ie : video/PIR) to support either version.

We have offered to third party up to global sum of \$8,000.00(all-in). However they have rejected our offer and proposed global sum \$12,000.00(all-in).
