


Pic A-1. Position of 5 Ton MID 20571



Brief Details.

On 22/06/15 at 1430hrs, (Driver: Jarek Sia Zuo Rui, S8851561G) was driving a military vehicle (MIB 20571) travelling towards a T-Junction.
