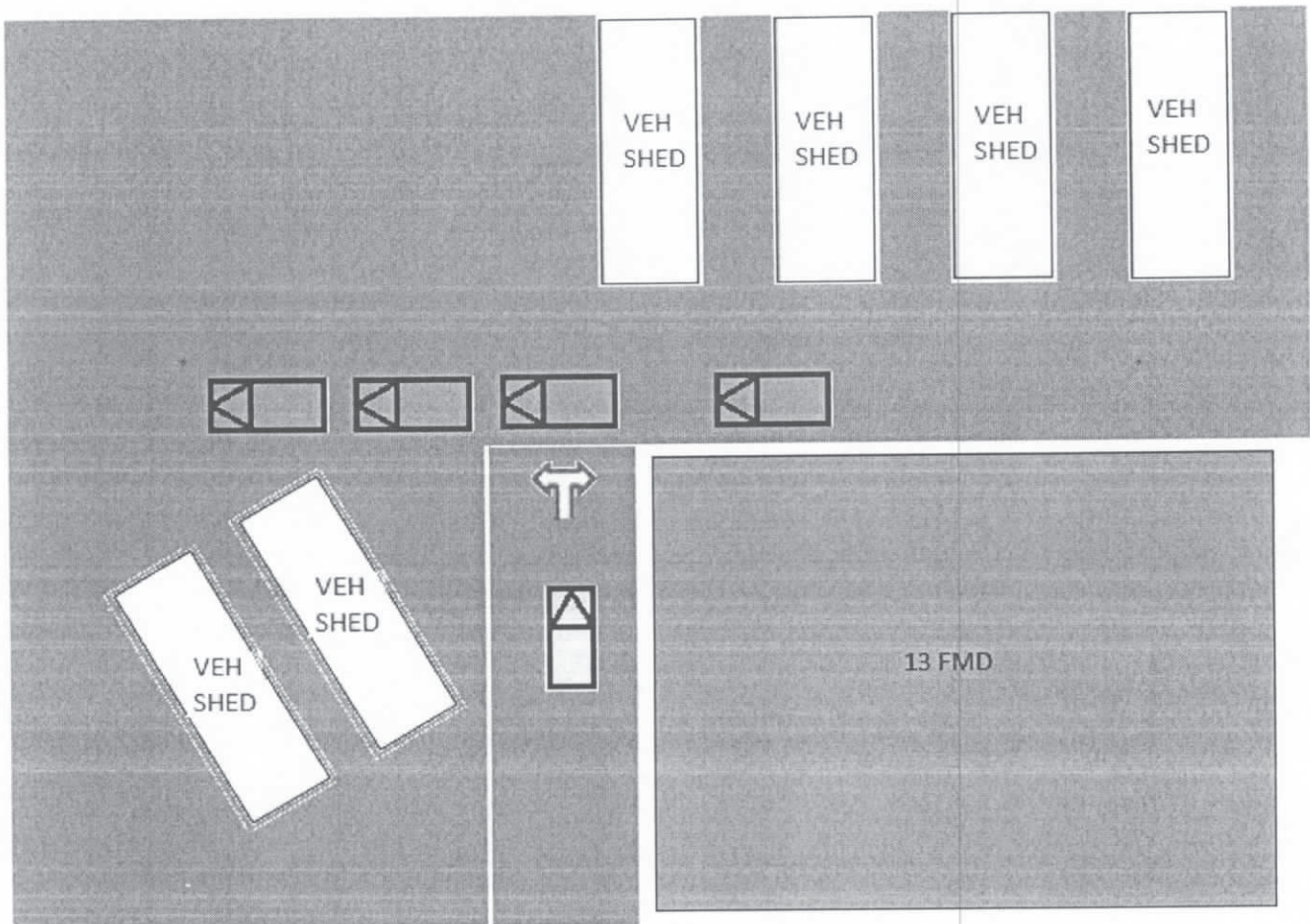

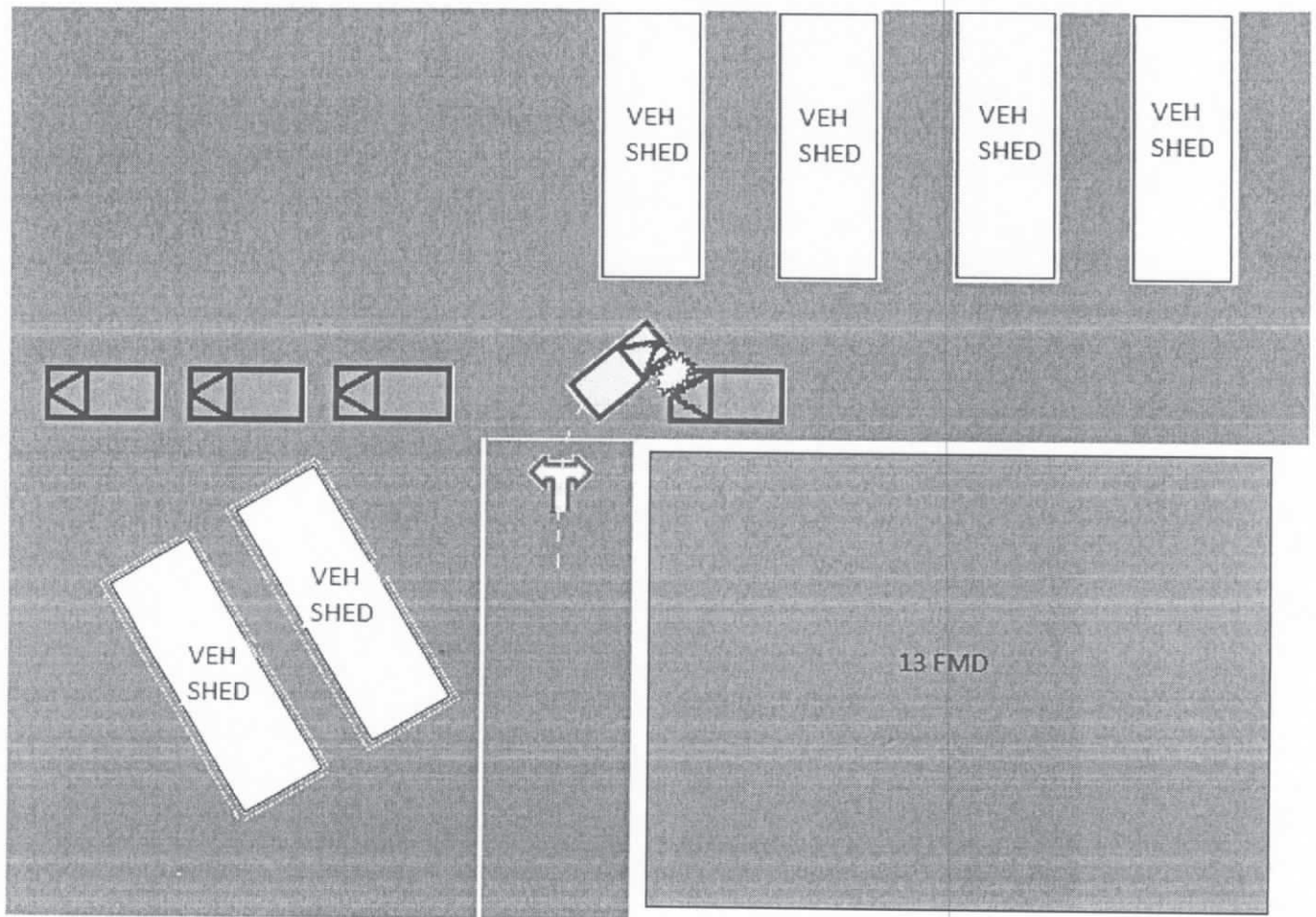
SCHEMATIC VIEW OF THE INCIDENT

Schematic B-1 : Before Incident



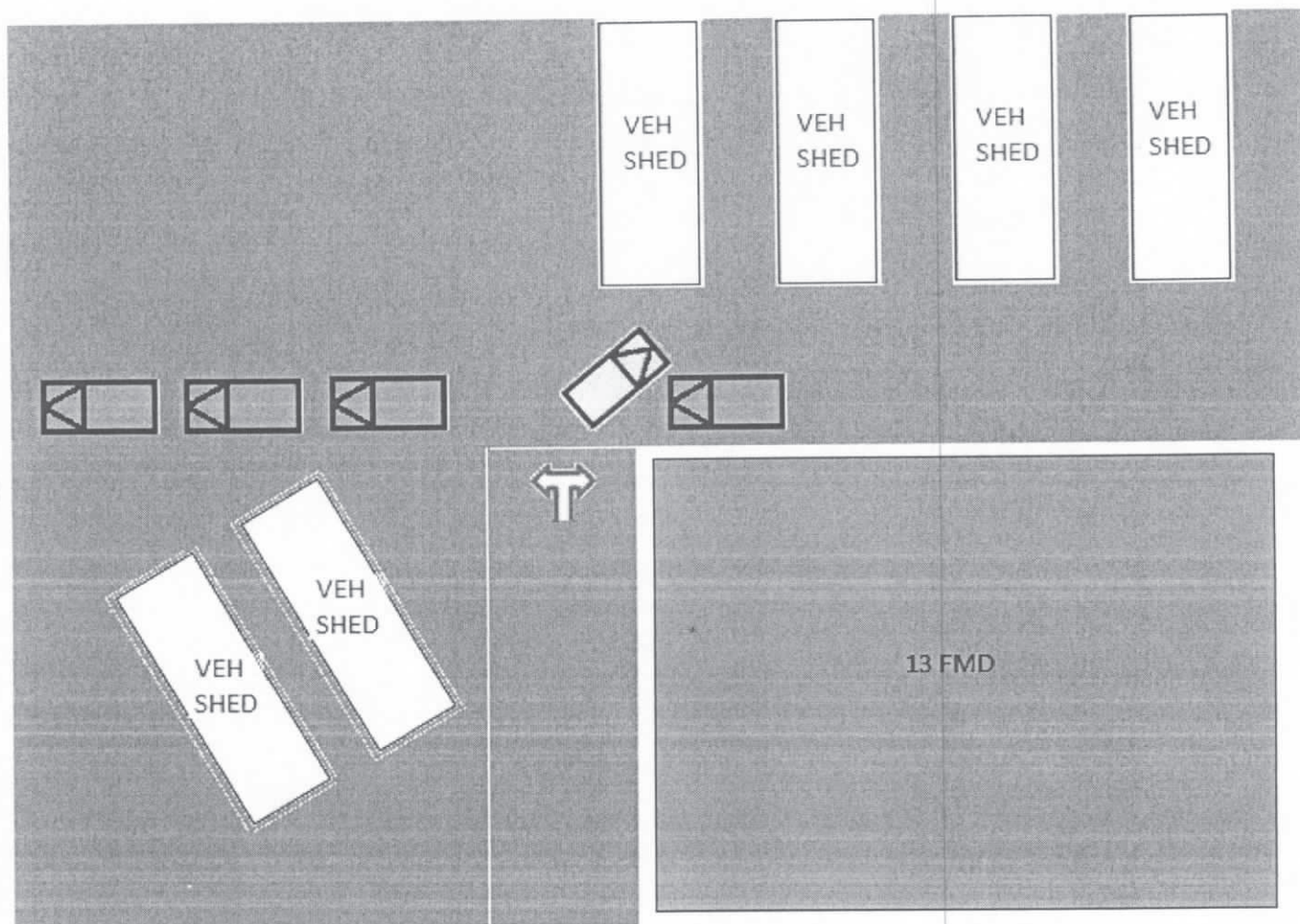

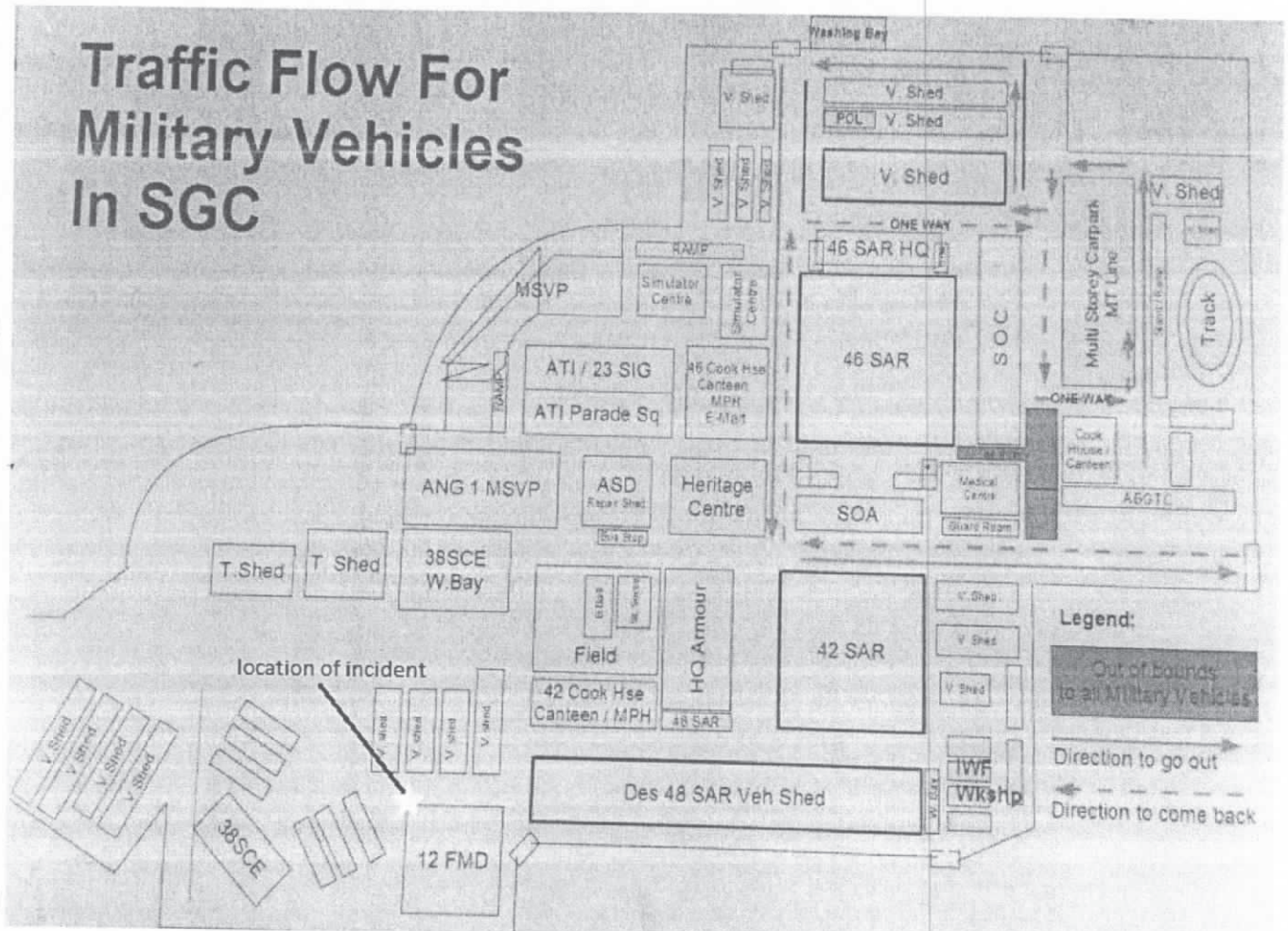
