

<p>I, NRIC: S93479451, Rank & Name: CPL BENJAMIN LIONG, WAS DRIVING MID 21253. I WAS COMING BACK FROM MUTF, GOING BACK TO MAJU CAMP. AS PER NORMAL, WE WERE GOING ON PIE(CHANGE) AND EXITED CLEMENTI AVE6, I WAS ON THE CENTER LANE AND WAS GOING AT 45 KM/HR - 50 KM/HR. I WAS NOT SPEEDING. FURTHER DOWN THE ROAD, THERE WAS A LEFT FILTER LANE. I WAS STILL CONTINUING MY DRIVE, AND SUDDENLY I FELT A NUDGE ON MY LEFT TIRE. MY STEERING WHEEL SHOOK AND I LOST A BIT OF CONTROL, CAUSING MY TONNER TO SHIFT INTO THE LEFT LANE. WHEN I FELT THAT THE TONNER WAS SLOWING DOWN FOR NO REASON EVEN THOUGH I DID NOT PRESS THE BRAKES, I STEPPED ON THE BRAKES AND CAME TO A STOP. I DID NOT HEAR ANY HORN, AND WHEN I CAME TO A COMPLETE STOP, I SAW A CAR IN FRONT OF ME. WHEN I STOPPED AND LOOKED DOWN AT THE DRIVER OF THE CIVILIAN VEHICLE, I ASKED "WHY ARE YOU USING YOUR PHONE". AS I SAW HER HOLDING HER PHONE AND WAS TALKING. AFTER THE ACCIDENT, I IMMEDIATELY CALLED MY SUPERIOR AND DID NOT MOVE THE VEHICLE.</p>



<p>On 040815 at around 1310 HRS, I 3SG MAVERICK was the vehicle commander for CPL BENJAMIN LIONG who was driving the 5-TON vehicle. We were coming from Mural Urban Training Facility heading towards Maju Camp. As per normal we were travelling on PIE(CHANGE) and we exited Clement Avenue 6. It was a 2 lane road. CPL LIONG was following the speed limit. After a certain distance, there was a left filter lane, which the road from 2 lanes into 3 lanes. CPL LIONG was driving on the center lane, and I was focusing on the road ahead of the tonner. After about 100 meters (give and take), and suddenly we both felt a nudge on the 5 TON's front left tyre and the car started to slow down. I said "STOP", but CPL LIONG was already stopping the 5TON. After we came to a complete stop, we saw a Honda Stream right in front of us. No honking nor any significant way to alert us that there was a car on our left-side trying to overtake us, all I heard and felt was tyre screeching and a nudge. Immediately, when CPL LIONG stopped the vehicle, he looked down at the driver and said in Chinese "Why are you using your phone?". After hearing this, I went down the TONNER without hesitation and ran to the left side of the car. I opened the left front door to check if the civilian (female) was fine. I saw her with an earpiece plugged into her ear and one of her hands was grabbing onto the phone. She exclaimed immediately to me that she was calling her husband. Immediately, CPL LIONG called his Clementi Node commanders and we stepped away from both vehicles.</p> <p>I have nothing else to add</p>

Brief Details.
