## Brief Details.

On 04/08/2015 at about 1.10pm, I was driving my car registration plate number SGY7036L and my daughter namely Li Yun Fei was seated on the passenger-seat behind of me. We just exited from the Pan Island Expressway and entered Clementi Avenue 6 towards AYE when we got involved with a traffic collision with a Singapore Armed Forced lorry registration plate number 21253 MID just before the junction of Clementi Avenue 6 and Clementi Loop.

I was driving on the extreme left lane of the three lane road when an army lorry filtered into my lane from the centre lane. I gave way to that lorry and once the lorry has fully entered the lane, a second army lorry attempted to filter to the extreme lane too but in the course of filtering in, the front portion of the lorry collided onto the rear right portion of my car and the impact caused my car to skid and spun facing the opposite direction. When it stopped, the front right side of the same lorry again collided into the whole right side of my car causing major damages to the right driver and passenger doors and also the rear right portion of my car.

I suffered cuts on my right arm during that point of time and later on I started to feel pain on the right arm up to the back of my neck. My daughter suffered shock. The other driver also alighted and informed me that the lorry was too high that he did not notice my car was on the extreme lane.

I and my daughter then went to seek medical attention later on. I was given 5 days of MC and my daughter was given 3 days.
