Kindly convey to your principal –India Ins. to withdraw this deny liability for this case.

We have attached the video clip for you to investigate this matter and to review this case again.

You can see our taxi driver turned out from China Town Point complex pick-up exit out and did not hit onto the Silver Cab SHC6194Z.

While our Trans Cab Taxi SHD943M already at the extreme left lane (ie the dotted bus lane) traveling straight at that position and behind the SBS Transit Bus;
the silver cab (SHC6194Z) just cut suddenly into the extreme left lane without due consideration and collided on the front right portion of our transcab taxi SHD943M
in which our taxi is already traveling straight and behind the SBS Transit bus.

My opinion is that the silver Cab is held full responsible for this accident without due consideration of others road user.

Kindly request your principle insurer (ie. India Insurer) to review this case again and to with draw the deny liability and to compensate full damages to us & our taxi driver.
