Brief Facts.

On 14 November 2015 at around 0605hrs, I was exiting the open space carpark into Sungei Kadut Street 3. I checked both lanes were clear before turning left into Sungei Kadut Drive. After turning into the lane, I felt an impact hitting my vehicle's front right portion. After that, I immediately lost consciousness. When I woke up, I found myself already in Ng Teng Fong General Hospital. I do not remember anything about the incident. According to the doctor's diagnosis, I suffered fractures in my right rib cage and right knee. I was subsequently given 21 days of MC After getting discharged from the hospital yesterday, I received a letter from Traffic Police [Ref: TP/IP/55963/2015] TP IO Putch Bte SHariff asking me to lodge a police report.
