Brief Facts.

Vide: E/20160330/0021. On 30/03/2016 at about 0345hrs, I had parked my vehicle (JHV6791) along claymore hill on the left side of the road with my hazard light on to drop my friend off. My friend then got off and proceed to my vehicle boot to get his stuff. While I was in my vehicle, I noticed from the right side mirror that a blue taxi (SHC8632M) coming at a very fast speed and suddenly, the taxi had hit onto my vehicle rear right side. My friend was seen to be hit by the taxi and landed beside my vehicle driver's door as well. I then got out of my vehicle from the front passenger door and proceed to assist my friend and also got the taxi driver to call for ambulance. Shortly, a police car happened to pass by and assisted me as well and also to call for ambulance.

My friend was conveyed to Singapore General Hospital and his right leg was broken. My vehicle also sustained damage on the back right fender, back right tail light and boot cover. Due to the impact, driver door and right passenger door was unable to be opened. My vehicle was hit by the taxi left front side to my vehicle rear right side.
