

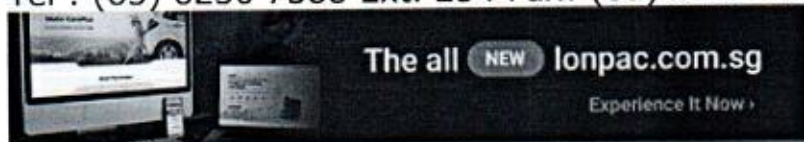

We refer to the subject matter and to the assignment dated 20th April 2016 of Third-Party's request to do Direct Settlement with our Principal, Lonpac Insurance Bhd.
