
Hope you can review this matter and let us have your best offer.

#### Brief Details.

On 17/05/2016 at about 1710, I was driving my taxi SHD9781D on the first lane on right side of Outram Road (Towards the direction of Cantonment Road). I intend to turn right into Holiday Inn, so I kept right and queue behind a few cars who were also turning right into Holiday Inn. Subsequently after I slowly arrive at the entrance to turn right into Holiday Inn, I started to turn right slowly at the speed of about 10~20kph. As the vehicle which was in front of me stopped, I applied my brake and became stationary. I few seconds later after I became stationary, I felt a strong impact coming from the rear right side of my taxi. I took a few moments to recover as the impact caused dizziness to me, then I came out of my taxi to make a check. I noticed that a lorry GW4965K had collided it's front into my rear right side, at the area near to my rear right wheel. My taxi suffered a dislodged rear bumper on the right side, which causes jamming on my rear right wheel. There is also several large dents and scratches on the same area. The lorry suffered only dents at the front right side. The lorry driver seems to be uninjured, and we took photo of the accident and vehicle registration number. Subsequently after that, the lorry driver left, and I called for tow truck to tow my taxi as my taxi's dislodged bumper is causing obstruction during any movement.

After that, I went to West Point Hospital to check my injuries as I suffered some pain on the back of my shoulder and my neck after the accident. I was given 5 days of MC due to the injuries.

This is not the first time I encounter such accident. I do not have any in-vehicle camera installed on my vehicle.
