Describe Circumstances of the Accident

ON THE 17 MAY 2016 AT APPROXIMATELY 19.30HRS I ENTERED DUNDEEN ROAD FROM SALAN ANAK BUKIT TRAVELLING IN THE DIRECTION OF THE CITY. I TOOK TO THE RIGHT AND ENTERED THE SLIP ROAD TO THE ENTRANCE OF GARDEN VISTA CONDOMINIUM TO DROP OFF A WORK COLLEGE.
I PROCEEDED TO THE ENTRANCE FOR DUNDEEN ROAD. I STOPPED AND CHECKED RIGHT AND DID NOT SEE ANY ONCOMING CARS, SO I ENTERED THE INSIDE LANE OF DUNDEEN ROAD. I STARTED ACCELERATING IN THE LANE (INSIDE). I ESTIMATE IT WOULD NOT HAVE BEEN 30 SECONDS LATER AS I ESTIMATE I WAS ONLY DOING 25-30KMH WHEN SUKUT TAXIS SUB 5411 Y ROUNDED INTO MY LANE FROM THE OUTSIDE LANE AND HIT MY FRONT RIGHT HAND PANEL WITH HIS BACK LEFT HAND PANEL.
SUB 5411 Y HAD TWO PASSENGERS.
WE PROCEEDED A SHORT DISTANCE AND BOTH STOPPED AT THE SIDE OF DUNDEEN RD BEFORE RIFLE RANGE TURN OFF AND THE OVERPASS.
I CHECKED THE DAMAGE TO MY CAR AND FOUND THE FRONT RIGHT HAND PANEL DENTED HOWEVER THERE WAS NO DAMAGE TO THE FRONT RIGHT WHEEL OR THE HEADLIGHTS AND INDICATORS. THERE WAS NO IMPAIRMENT TO DRIVE THE VEHICLE. THERE WAS SIMILAR DAMAGE TO SUB 5411 Y REAR LEFT HAND PANEL WITH NO IMPAIRMENT TO DRIVING.
WE EXCHANGED DETAILS SUCH AS PHONE NUMBERS, LICENCE NUMBERS AND NAMES. I DID NOT DISCUSS THE ACCIDENT OR BLAME.
WE BOTH GOT BACK INTO OUR RESPECTIVE CARS. SUB 5411 Y TURNED LEFT INTO RIFLE RANGE ROAD. I BELIEVE HE WAS TRYING TO CHANGE LANES TO MAKE THE LEFT TURN INTO RIFLE RANGE ROAD WHEN HE HIT ME.
I DROVE TO MARINE PARADE NORTH ROUGHCOO POLICE POST AND EXPLAINED THE ACCIDENT AND CIRCUMSTANCES TO THE OFFICER AND ENQUIRED ABOUT MAKING A POLICE REPORT. I WAS TOLD BY THE OFFICER THAT AS IT ONLY INVOLVED 2 CARS AND THERE WERE NO INJURIES AND THE ACCIDENT WAS MINOR THERE WAS NO NEED TO FILL OUT A POLICE REPORT.
I ATTACH 2 DIAGRAMS SHOWING THE ACCIDENT LOCATION AND DETAILS.




