CONTINUATION OF REPORT

Brief Details.

On 16/06/2016 at about 2220hrs, I was driving my taxi (SHD 9279 M) along PIE towards BKE with one passenger on board. As I was about to enter the BKE entrance, a vehicle in front of me (SGM 9726 D) suddenly braked. As I wanted to avoid a collision, I immediately stepped on the brakes and managed to avoid colliding into the vehicle in front. A few seconds later, I felt I strong impact from the rear of my vehicle. The next thing I knew was that I felt immense pain near to my neck area and felt a little groggy.
