CONTINUATION OF REPORT

Brief Details.

On 16/06/2016 at about 2220hrs, I was driving my taxi (SHD 9279 M) along PIE towards BKE with one passenger on board. As I was about to enter the BKE entrance, a vehicle in front of me (SGM 9726 D) suddenly braked. As I wanted to avoid a collision, I immediately stepped on the brakes and managed to avoid colliding into the vehicle in front. A few seconds later, I felt a strong impact from the rear of my vehicle. The next thing I knew was that I felt immense pain near to my neck area and felt a little groggy.

I went down my taxi and realized that another taxi (SHB 9719X) had collided into my vehicle. I was unable to make a check if all the involved parties are safe as I was feeling very unwell at that point of time. A while later, police and ambulance arrived at the scene and conveyed my passenger and I to Ng Teng Fong Hospital where I was given 2 days of Medical Leave.

I wish to state that my vehicle's rear is badly damaged but it can still be driven. As such, I am lodging this police report for my company's record purpose. That is all.
