

CONTINUATION OF REPORT

Brief Details.

On 28/06/2016 at about 1830hrs, I was driving my vehicle bearing registration plate no. SJU146U, along the Changi Coast Rd, heading towards EXP exit. I was driving along the 3rd lane of the 3 lane road as I wanted to exit to ECP. As I continued forwards, I noticed that there was a lorry, bearing registration plate no. GBE3116E, which was parked illegally along the outer lane on the double yellow line in front of me had blocked the traffic. There was a moderate traffic on my right side and I was unable to perform a lane switch, as such, I had to slow to a stop.

Subsequently, I heard a loud car horn from the back and looked into the rear view mirror. I noticed that a large construction truck, bearing registration plate no. Xe463L, coming towards me at a relatively high speed. The truck driver continued to honk at me and I was still trying to make a lane change however was unable to. After which, the truck crashed into the my vehicle from the back and caused my vehicle to move forward and hit on to the railing and wall which caused my front portion of my car to be damaged. However it did not hit onto the lorry which was still parked in front of us.

The other two drivers and I then got down off their vehicles, and the drivers of the truck and lorry then started to argue. They then called in the police whom came down shortly after. I asked the lorry driver why he had to stop at the double yellow line and he told me that he had actually kept in the wrong lane and wanted to change to the first lane from the third lane, heading to Changi, however the traffic was too heavy and he was unable to do so, and as such he parked his lorry.

Subsequently, the two officers namely SSGT Samuel and SSGT Azreen attended to us. They then provided me a case reference number G/20160628/0151 and instructed me to lodge a traffic accident report. The lorry and the truck was then able to move off their car from the location. Only my car was totally damaged and I had to call for the towing crew. I do not feel any discomfort and as such I did not seek any medical treatment.

I wish to state that the lorry driver should not have parked his car at the road side just because he had kept to the wrong lane. His selfish thinking has caused a traffic accident today. The truck driver was an errant driver as well as he was speeding, If he had not drove at such a fast speed, he might have been able to stop in time to avoid colliding into my vehicle.

I also wish to feedback that I frequently travel this road and I would sometime see lorries and trucks parking illegally at the side of the road like what the lorry driver did today. This have always cause traffic congestion at the exit, and is a potential traffic hazard, and I wish that the traffic police would do something about it.

Due to this incident my vehicle had sustained serious damages in the front and rear of my vehicle.
