<p>I, NRIC:S9436932J, Rank & Name: LCP Low Jon Hon would like to report this incident which happened on 07-07-16 at about 2100Hrs at Loyang Avenue at the traffic light junction on left turning to Old Tampines Road.</p> <p>On 07/07/16, I was tasked to carry out a detail to move a 5 Ton MID 21238 from Changi Naval Base to Sembawang Camp.</p> <p>When I was travelling along Loyang Avenue, I saw the traffic junction is ongoing to turn red, so I slow down and stop my vehicle, as at point of time, my vehicle was the first vehicle and I kept on the middle lane. So that on next junction about 200m, I am able to make a right turn into TPE/SLE.</p> <p>Once I saw the traffic light turned green, I release the brakes pedal suddenly felt an impact and sound coming from the left side, I immediately brake and I noticed that a Mercedes (SDC2200E) had come very close to the left side of my vehicle. After that my 5 Ton and the Mercedes (SDC2200E) move forward a bit and stop at extreme left lane to avoid holding up the traffic.</p> <p>This is all I have to say.</p>

<p>I, S9407337E, CPL Yeo Chin Leong is writing this statement form about the traffic incident which happened on 07/07/16 at about 2100hrs at Loyang Avenue at the traffic light junction on left turning to Old Tampines Road.</p> <p>I was picked to support a NDU detail on 08/07/16 at 0515hrs and was required to have the parkdown of the vehicle on 07/07/16.</p> <p>I drove MID 33779, OUV and left camp at 2030hrs. At 2115hrs, along Loyang Avenue before filtering towards TPE(SLE), LCP Jon Hon all of a sudden filtered towards the left and stopped. I went ahead of him and pulled over to see what the issue was. I then realized that a civilian driver pulled over at the roadside and approached us claiming that we hit his vehicle. He directed us to the damages. He also claimed that we moved before the light turned green and that as a left lane user, he would have the right of way and that he should move off first.</p> <p>I am firm and positive that the 5 Tonner was well kept in the center of middle lane and that there should be no reason for him to veer left as we are going to filter towards the right. I am also certain that the traffic light turned green before MID 21238 moved off.</p>
