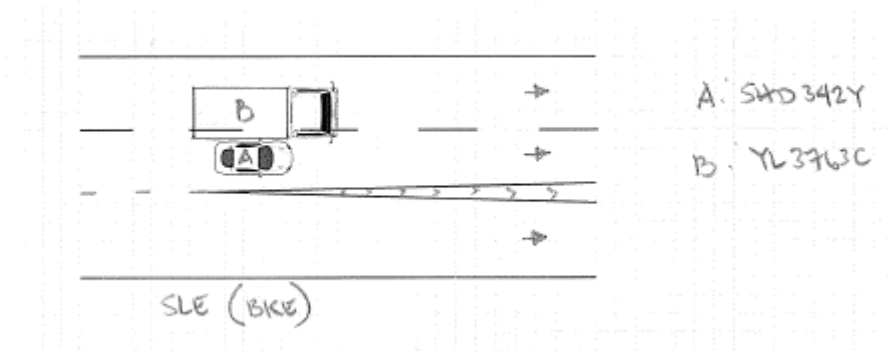
Enclosed is the video footage for your investigation.

From the video you can see, our driver is already traveling straight in the lane and your insured vehicle suddenly swerved into our taxi lane.

Circumstances of Accident

On 20.08.2016 at about 1253hrs, I was traveling at the right lane along SLE towards BKE when Vehicle B (YL3763C) which was on my left suddenly swerved into my lane without checking for oncoming vehicles. Thus resulted, vehicle B's right side portion collided onto my taxi's left side portion.
