We refer to the above matter.

Third party reported that he was stationary along Kitchener Link checking for oncoming vehicle on the opposite lane as he intended to make a right turn towards City Square Residence. After traffic clear, third party slowly proceed to make a turn when suddenly our insured overtook his taxi and travel at the opposite direction. Thus resulted the collision.

Our insured driver reported that he was travelling along Kitchener Link behind third party taxi. Then third party stopped without any indication, our insured driver had waited for a while, but third party did not move off, so he overtook third party taxi. When insured driver was driving pass third party, third party suddenly turned right and hit onto our insured lorry.


