Brief Details.

On 10/09/2016 at 0630hrs, I was travelling from Geylang towards Jurong in my Singapore registered vehicle bearing registration number FBK8652J. As I was travelling on the accelerating lane towards PIE, a Singapore registered vehicle bearing registration SHB4413K (Comfort Delgro) banged on the rear bumper of my vehicle. As a result of the collision, I skidded with my motorcycle for about 10-15metres away. The other vehicle managed to make an emergency brake upon realizing that it had banged onto me. My vehicle was severely damaged due to the collision. On the other hand, the other vehicle suffered slight damages on the left front headlight bumper of the vehicle.

I wish to state that SCDF and ambulance was at scene. I was conveyed to Changi General Hospital and suffered several injuries such as Contusion on my right knee, Head injury, Neck sprain and abrasion on my right elbow, right knee, right ankle and right wrist. I was given 05 days of MC by the hospital from 10/09/2016 to 15/09/2016. I also wish to state that I did not manage to take a photo of my damaged vehicle as well as the photo of the other party's damaged vehicle as I was busy being attended by the ambulance.
