#### Circumstances of Accident

AT 7.00AM ON 14 SEPTEMBER 2016, I WAS DRIVING MY VEHICLE 'A' ALONG HAIG ROAD WHEN A CAR BEHIND ME VEHICLE 'B' KNOCK MY REAR BUMPER. THE IMPACT ON MY CAR CAUSED ME TO KNOCK THE VEHICLE 'C' IN FRONT OF ME. THE VEHICLE 'C' IN FRONT OF ME IN THEN KNOCK THE VEHICLE 'D' IN FRONT OF HIM. THIS RESULTED IN A 4 CAR CHAIN COLLISION. MY WAS DAMAGED, REAR BUMPER, FRONT BUMPER, LICENSE PLATE CAME OFF AND MY BOOT DOOR WAS DAMAGED. THE DAMAGED INCLUDED MY REAR VIEW CAMERA. THE DRIVER WHO STARTED THE COLLISION CAME OUT TO APOLOGIZE AND PROMISED TO COMPENSATE US. WE TOOK DOWN EACH OTHER PARTICULARS AND TOOK SOME PHOTOS AND THEN MOVED ON.

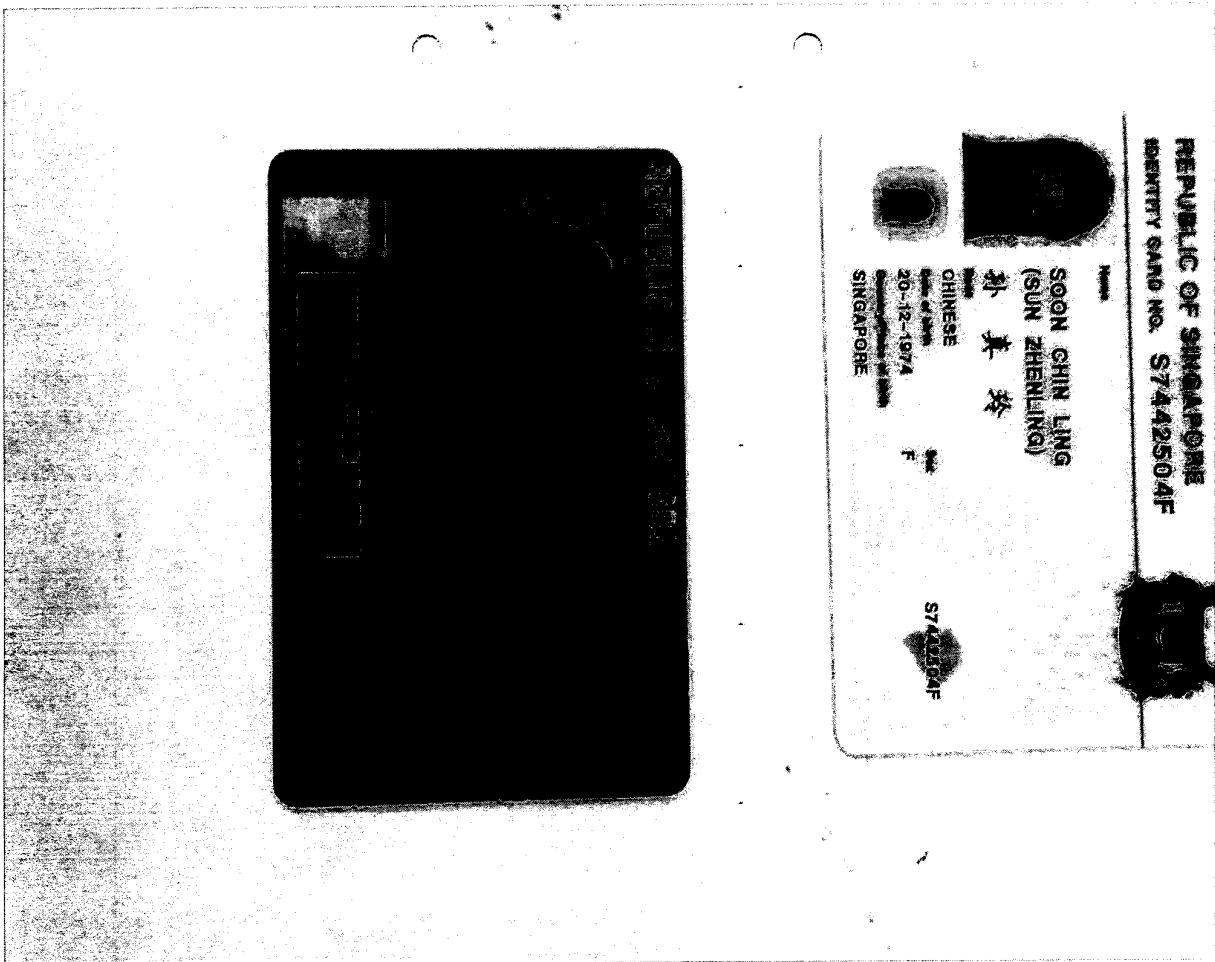

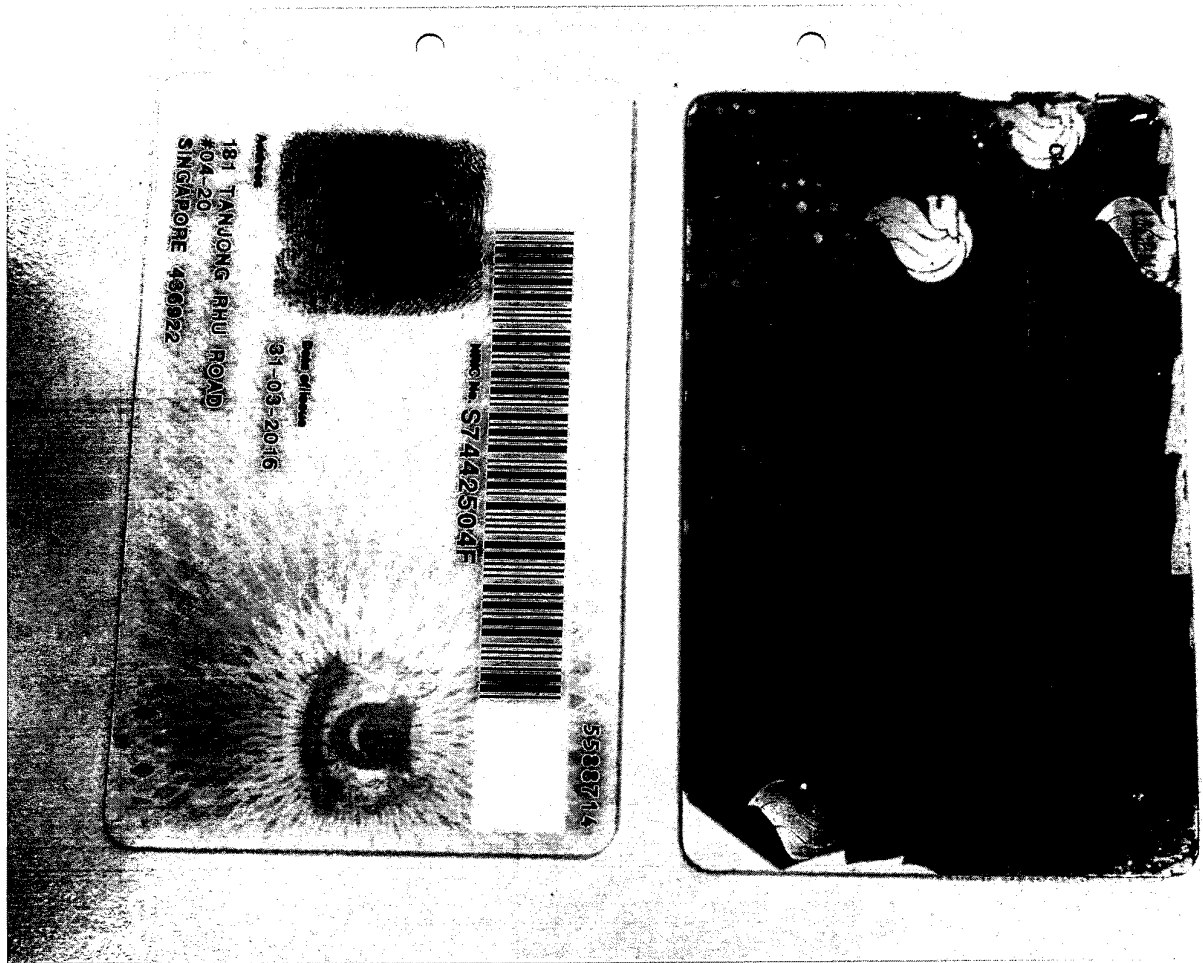
