Thank you for your email, the content of which is noted. We do recognize KTC has got a maintenance contract in place with VOLVO.

However, insofar as the indemnity under the motor insurance policy is concerned, we have the duty to mitigate claims.

This is a 2012 vehicle which will be indemnified under lumpsum repair basis as per market practice and policy conditions.

For the sake of discussion, we would like to present our case as follows for analysis.

Volvo has quoted \$134K++ for this repair. The market value of this vehicle (make and model) is \$120K. Because the vehicle is a 2012 vehicle and is subject to lumpsum repair, Volvo has undertaken to make good the repair at \$82K which is the economic repair value considering the market value and LTA rebate at the time of loss. From our tender efforts amongst our panel of authorised repairers, based upon the similar basis and scope of repair, we have garnered repair cost of \$50K which represents a saving of 39%.

Insofar as policy indemnity is concerned, it makes no economic sense for insurer to repair the vehicle at \$82K if we can do the same at \$50K. (savings of \$32K)

We would also like to advise that it would also be in the interest and duty of Kok Tong as the principle to mitigate claims exposure which will also play a part in containing the premium rate.

This being a loss which had arisen from an unforeseen accident and one to be indemnified under the terms and conditions of the motor insurance policy, it is our recommendation that the vehicle be repaired at GAIC's authorised workshop.

We trust the foregoing explanation is not unreasonable and is clear and that we look to your favorable corporation with GAIC in order that the matter may be handled expeditiously without further delay.
