On 02/11/2016 at around 0820hr. I was driving a SAF combat ambulance (MID34649) along Sentosa Gateway turning right into Telok Ellangah road on the 3 lane road. My vehicle was on the extreme right lane when the accident happened.

I was about to make my right turn after the traffic turn green when another vehicle on my left who was also turning right into Telok Blançah road cut partially into my lane and grazes onto the left front bumper of my vehicle. The said vehicle did not stop and continue to move straight after completed the right turn into Telok Blangah road.

I then tried to manoeuvre a lane change from the extreme right to the left in order to stop at the road side to check on the damages, however due to the heavy traffic I was unable to do so. I then continue to driving straight into Kampung Baliru thereafter filtering to the right wanting to make a U turn to the other side of the road. However while coing so on the second lane from the extreme right to the extreme right lane a vehicle SJN845L on the extreme right lane came and lightly grazes onto the right rear of my lane a vehicle. I was later able to complete my lane change before the said vehicle over take me from the left and stop her vehicle in front to confront me on the accident, both of us later exchange our details before move off.

I wish to inform that for the first ir cident I did felt a contact made, however the other driver did not stop and continue driving. For the second incident I did not notice any contact made until I was notify by a fellow driver driving past and later by the driver herself.

Damages to the SAF vehicle were scratches on the front left bumper due to the first incident and light

Or. 02/11/16, I LCP NICHOLAS CHIN was on a detail for SOTAC IFly located in Sentosa. I left PRC at 0600 after collecting the entry pass from WO Melvin and the medic. I took the authorised route to Sentosa via TPE, SLE, BKE, KJE, PIE, AYE and exited at Lower Delta Road and onto Telok Blangah road. I then took a left turn onto Sentosa gateway.

I was at the extreme lef: lane and made a wrong turn into Resorts World carpark as I lost my way and ended back on Sentosa gateway travelling back to Telok Blangah Road. I wanted to anticipate a U-Turn to go back to Sentosa so I kept to the right lane. At the controlled T Junction at the end of Sentosa gateway, a small grey lorry and I were the first few vehicles at the traffic light waiting for the traffic light to turn green. The lorry was in the middle and I was on the extreme right lane. Both of us moved into the right turn pocket when the traffic turned green.

I immediately stopped and give way to the lorry when I noticed that the lorry was turning too close to my pocket. The lorry drove off after

hitting my front left bumper. I turned into the right lane onto Telok Blangah road, having the intention to stop on the road shoulder to check the situation but due to the heavy traffic on the left, I decided to find a safe place to make a U-turn first. I checked that the lane was clear and I signalled right on Telok Blangah Road before making a lane change when a white SUV stopped behind me. I carried on driving, thinking nothing of it, being now on the right lane. Another driver drove beside me on my left and gestured to me that I got hit. He drove off and I slowed down while the victim driver drove and stopped infront of me.

We stopped our vehicles along Telok Blangah Road on the lane to make contact. Ms Hazleen, the driver of the vehicle showed me the damages on her vehicle. I called Selarang Node right away, not knowing how to handle the situation. The medic, PTE Gabriel talked to Ms Hazleen while I was on the phone. Ms Hazleen gave PTE Gabriel her contact details and left after that.
