

We refer to the above references. The accident occurred and assignment was given last 2014.

We submitted our WP report to your good-office on 18/04/2017 due to inactivity.

Now, we received LOD from TP repairer however, no evidence was furnish despite our request.

The adjusted repair cost is at \$850.00 after survey.

We required evidence from TP as their driver <u>reported a front-to-rear scenario</u> that occurred on the same lane where TP damages did not correspond with our insured's report and damages sustained on its front right hand side.

Attached damage photos for comparison and your reference.

In view of the above, we are of the opinion that OI's version is more <u>probable.TP</u> likely changed lane and OI's evasive reaction to avoid collision fall short hence, contact of their vehicles.

As such, in the absence of strong evidence from both, an equal liability settlement of 50:50 is already reasonable solely for the purpose of an amicable settlement and to bring this 2014 claim to end.
