Circumstances of Accident

I WAS DRIVING ALONG TAI THONG CRESCENT AND HAD THE INTENTION OF TURNING RIGHT INTO SIANG KUANG AVENUE. THERE WAS A TAXI ABOUT 5 METRES AWAY FROM THE JUNCTION OF THE TWO ROADS. THE TAXI WAS IN A STATIONARY POSITION IN THE MIDDLE OF THE LANE. I ATTEMPTED TO DRIVE FURTHER FORWARD TO OVERTAKE THE TAXI BEFORE TURNING TOWARDS THE RIGHT LANE INTO SIANG KUANG AVENUE. THE TAXI AT THAT MOMENT SUDDENLY MOVED FORWARDS WHILE I WAS MAKING MY TURN TO THE RIGHT, THE TAXI HIT AGAINST THE REAR SEAT CAR DOOR ON THE CAR'S RIGHT SIDE, SCRATCHING THE PAINT OFF THE CAR. HIS CAR MOVED SLIGHTLY FROM A STATIONARY POSITION AND MY CAR WAS MOVING AT A VERY SLOW SPEED. TAXI DRIVER IMMEDIATELY GOT OUT OF THE TAXI AND STARTED TAKING A LOT OF PHOTOS. 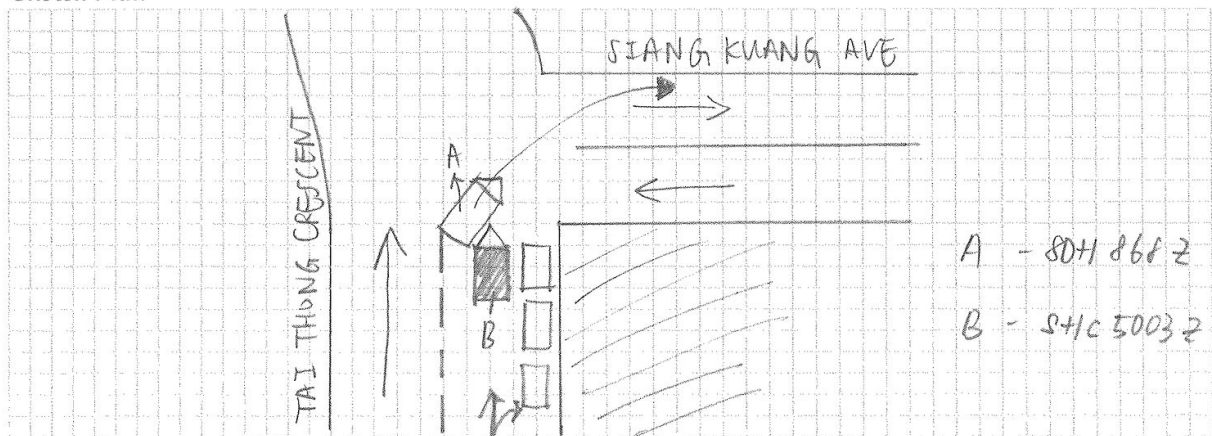

Describe Circumstances of the Accident

I WAS DRIVING ALONG TAI THONG CRESCENT AND HAD THE INTENTION OF TURNING RIGHT INTO SIANG KUANG AVENUE. THERE WAS A TAXI ABOUT 5 METRES AWAY FROM THE JUNCTION OF THE TWO ROADS. 
