

Describe Circumstances of the Accident

I was driving my vehicle along Bedok Central Dr around 12.45pm on 16 July.

At the junction T-junction, the traffic from intersecting road seemed clear with ~~at~~ the vehicles ahead were all progressively turning right smoothly. Unfortunately, the vehicle just right in front of me SLP 4194X decided to stop and I had to make an emergency brake as a result. Both drivers got out of our cars to check out the condition of our cars but did not see any visible damage.

The driver of the car, Lee Chin Ying Jeanie (91053957), told me that ~~the~~ she is a grab car driver and ~~the~~ the car does not belong to her. So even though the car looked ok, she will have to report to the driver. With that, we exchanged contact.

In the evening that night, I received an sms from her that Car Club (possibly under Grab) requested her to report to idoc for car insurance reasons even though she told them it is not an issue.

On 17 July, I received a call from the car owner/workshop while I was in a meeting and was informed that they will be pursuing this as they encountered issue closing ~~the~~ the car boot. Told them I will contact them again later.

~~After my discussion with my father that night,~~ Then, I was asked if I would prefer settlement in private or via insurance claim.

After my discussion with my father that night, I replied him the next day to update preference to go through insurance given the circumstances. No further updates from them thereafter until we received the letter from them on 26 July 2017.






