We do not agree to your 50% offer below.

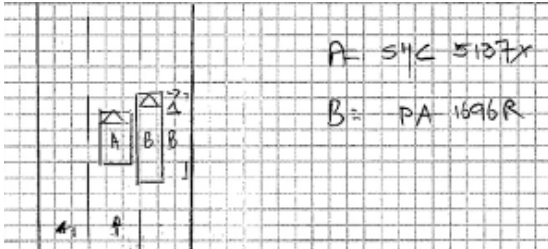
Based on the damaged photo, we are of the opinion that our driver's report is more accurate probable.
