Brief Details.

On 13/09/2017, at about 12.30pm, I was driving my car along Bishan St 21 (towards Marymount Road). At the junction of Bishan St 21 and Jalan Pemimpin, I slowed down as I intend to make a right turn into Jalan Pemimpin. The traffic light was green on my favour and there was no on coming vehicle on the opposite direction. As the traffic was clear, I made a right turn into Jalan Pemimpin however when I made the turn, suddenly there was a motorbike came from the opposite lane and collided onto my left side of my vehicle.

The rider fell due to the impact. I drove my vehicle into Pemimpin Place and parked along the road. I went back to the accident scene to render assistance. Subsequently ambulance and police also came down to the accident scene. The rider was conveyed to hospital by ambulance. 
