## ACCIDENT INVOLVING GBG 4313K(OI) & XD 9670B(TP) ON 04/10/2017

Third party reported that our insured was changing lane and collided onto the left front of third party's truck.

Our insured reported that third party knocked onto the right rear side of his vehicle.

We did clarify with insured the nature of the accident and there was no any video footage/scene photos provided by insured. We have advise to insured there is 50/50 liability based on conflicting version and he agree to let insurance handle. Insured aware that NCD (if any) would be affected.

We have started to offer \$2,450.00(all-in) at 50% liability to third party and improve to \$3,000(all-in) at 60% liability. However, third party provided the scene photo and counter propose \$4,000.00 at 80% liability. We have reviewed the matter & based on third party's scene photo, the position of third party's truck was on the right most lane, the front bumper of third party's truck was being pulled out and the damage parts was falled in front of third party's truck, it is likely the accident was happened on the right lane. As such, we are of the view that third party version is credible.
