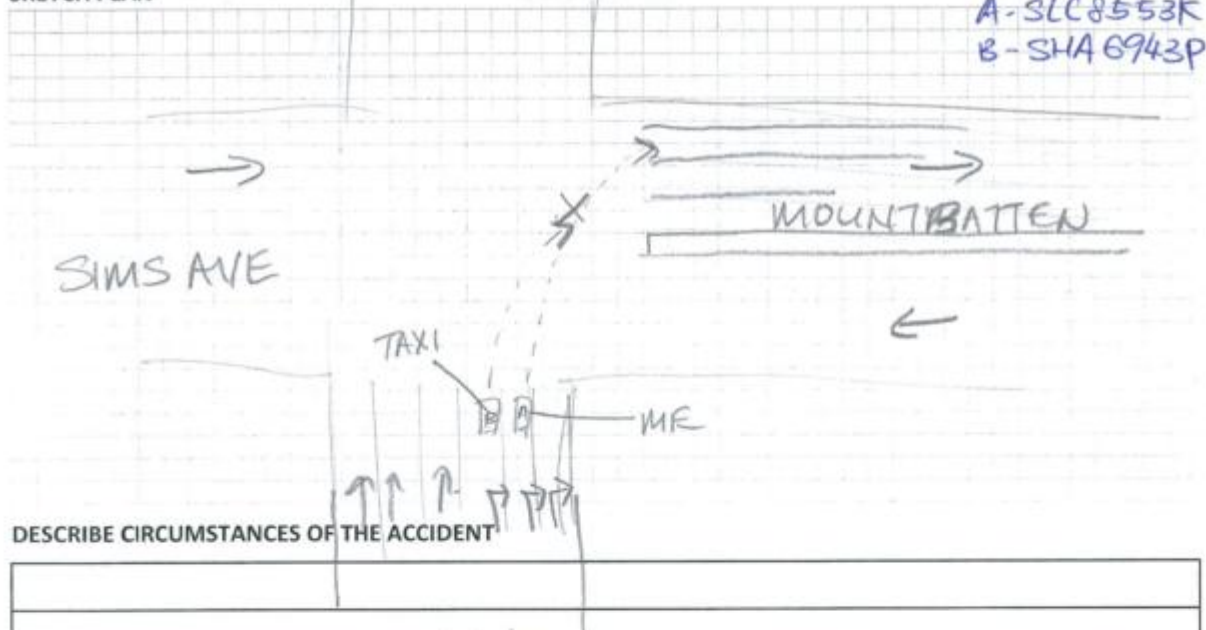

AT APPROXIMATELY 7:30PM ON OCT. 5, A COMFORT DELGRO TAXI SCRAPED INTO THE LEFT SIDE OF MY CAR. WHILE TURNING RIGHT FROM NICHOL HIGHWAY INTO MOUNTBATTEN RD. I WAS IN THE CENTRE RIGHT TURN LANE AND THE TAXI WAS IN THE LEFT MOST RIGHT TURN LANE. WHILE BOTH OF US WERE TURNING RIGHT, I FELT A LIGHT BUMP INTO THE LEFT SIDE OF MY CAR. THE MIDDLE SECTION OF THE RIGHT SIDE OF THE TAXI MADE CONTACT WITH THE LEFT SIDE OF MY CAR. TWO PASSENGERS WERE FOUND PRESENT IN THE TAXI.
