

Accident Report

I was driving to Kallang McDonalds to buy dinner. I parked my dad's car, a Black Volkswagen Jetta Sport, SKL5883AS, on the 4th lot of the carpark that is facing Kallang KFC. There was a lorry, GBB4510J, parked beside me. The lorry was parked head-in, facing McDonald's, while I was parked rear-in, with my front facing KFC. See diagram below.



After I parked the car, I alighted and was heading to McDonald's to buy some dinner when I heard a creak and the sound of metal brushing against metal. I turned around and I saw the lorry trying to reverse out of its lot, and I saw the LEFT SIDE hitting the LEFT SIDE of my dad's car.

Instinctively, I yelled at the driver, who immediately stopped. For some reason, he didn't seem to hear or feel the impact of this. He immediately got off and I walked over and asked him what he was doing. He claimed that he DIDN'T SEE my car, and he thought there was NO CAR in the Parking Lot beside his lorry.

I was furious as it was obviously his fault due to his driving incompetence. He reiterated that he did not see any car beside him. But my car was already parked PROPERLY IN THE LOT beside him. I fail to see how he missed my car. Even if he didn't see my car, which he should have, his turning radius out of the Parking Lot was way out of line, and it would have hit any other car that happened to be in his way.

We didn't argue much, as I didn't see any point in doing so. We took a few pictures, and we then exchanged particulars and we left the scene at about 10.25pm.


