On 01/11/2017 at about 1750hours, I was driving on the 1st lane of Robinson Road towards 1 Marina Boulevard when I heard a whisking sound of my left-rear door. I turned and saw a red-colored taxi had brushed against my left-rear door. In order not to obstruct traffic, I drove a little further and stopped near Ascott Raffles Place Singapore at 2 Finlayson Green. I waited there for approximately 15 minutes, but I did not manage to spot the taxi driver to exchange particulars with me. I checked my left-rear door and found some minor paint marks.

No one was injured. There is no inbuilt car camera in my car. On 02/11/2017 at about 0830hours, a TP IO Norameera called me to inform about the accident A/20171101/0125 and she informed me to lodge a traffic accident report at the nearest police station.
