that he was warning me of the upcoming vehicle, my vehicle had already made contact with the vehicle in front.

- 4. I wish to state that, I did not manage to stop in time and knocked into the rear end of the civilian vehicle. SLM4476Z, Toyota Prius Hybrid, driven by \$85302003 Mr Muhammad Khairul Johani Bin Jurpahat (Contact number: 85968701). The traffic condition then was heavy anti-the road was wet due to the rain. There was no injury to any personnel and the damages to the Opti Vehicle (SUR 9404X) was slight. There was no visible damage to the civilian car.
- 5. I wish to state that at the point of the accident, my eyes were feeling strained due to long hours of work since 1330 hrs. I wish to state that I moved out together with 3SG Jastint, 3SG Xing Ting Kai and 3SG Zhang Gingyang at about 1330 hrs to 31 Chai Chee Ave for an house search. We reached 31 Chai Chee Ave at about 1425 hrs and left at about 1442 hrs to Tengah Air Base Medical Centre for FFI. We were unable to conduct a house search then because the serviceman's father was not in the house and the serviceman did not have his house key.
- 5. I wish to state that we reached Tengah Air Base Medical Centre at about 1535 hrs and left at about 1625 hrs to return to MP Command and reached MP command at about 1635 hrs. After we reached MP command, 3SG Jastint, 3SG Xing Ting Kai and 3SG Zhang Gingyang escorted CPL Muhammad Ridzwari back to the Escort Processing Office (EPO). We had a AAR at about 1720hrs and moved out to refuel the Ops Vehicle at Choa Chu Kang Shell station. We returned to MP command at about 1820 hrs to 1830 hrs. I wish to state that we moved out for the 2<sup>rd</sup> house search at 1855hrs.
- 7. I wish to state that, I was informed about the house search on 4 Nov 17 at about 0003hrs by 3SG Jastint. He told me that 1WO Zaini tasked me to drive the team down to the accused's house to conduct the search, and 3SG Jastint also told me that he will inform me when he was done with the statement taking.
- 8. I wish to state that 3SG Jastint did give me warning by calling "Sir, Sir, Sir, However, I did not understand the warning given by him quickly enough. I also wish to state that, at the point of accident, My eyes felt strained.
- 9. The above-mentioned statement was given by me to the investigation Officer under no inducement, threat or promise. I was given the opportunity to read the statement and add or amend any part of it, I affirm it to be true and correct. I also affirm that I will not disclose or discuss any contents of this statement to persons not authorised to receive it / connected to this case. I will keep this statement to the strictest confidence. That is all.
