I, Self Statement, administer the following warning to the witness:  
"I am conducting an investigation into an offence of Road Traffic Accident at KJE Exit 3 towards Choa Chu Kang Way alleged to have been committed on 4 Nov 17 at about 2045hrs. You are bound to state truly the facts and circumstances with which you are acquainted concerning the matter under investigation and shall answer every question put to you in the course of the investigation provided that you may decline to make a statement which may incriminate you"

1. I wish to state that, I am the above-mentioned currently working as a Militray Policeman in Special Investigation Branch since Jun 2012. I am Single and currently reside at the above-mentioned address with my family. My highest education attainment is NITEC in the English medium.

2. I wish to state that on 4 Nov 17 at about 2020 hrs, I was driving the SIB Ops Vehicle, Toyota Altis unmarked, MID: 40915 (SJR9404X) to Tengah Air Base Medical Centre for FFI after a house search at 31 Chai Chee Ave for S9826212D NSF/ CPL Muhammed Ridzwan (a Close Arrest Personnel who was arrested for an drug offence).

3. I wish to state that at about 2045 hrs, I was driving on the center lane of the road approaching Chua Chu Kang way from KJE exit 3. I noticed that the traffic light I was approaching turned "Red" and started to slow down. However, I did not notice that there was an vehicle in-front of me at that of time. 313G Jastint, the vehicle commander, was calling me "Sir, Sir, Sir" but when I realised

that he was warning me of the upcoming vehicle, my vehicle had already made contact with the vehicle in front.

4. I wish to state that, I did not manage to stop in time and knocked into the rear end of the civilian vehicle, SLM4476Z, Toyota Prius Hybrid, driven by S8530200J Mr Muhammad Khairul Johari Bin Jumahat (Contact number: 85968701). The traffic condition then was heavy and the road was wet due to the rain. There was no injury to any personnel and the damages to the Ops Vehicle (SJR 9404X) was slight. There was no visible damage to the civilian car.

5. I wish to state that at the point of the accident, my eyes were feeling strained due to long hours of work since 1330 hrs. I wish to state that I moved out together with 3SG Jastint, 3SG Xing Ting Kai and 3SG Zhang Qingyang at about 1330 hrs to 31 Chai Chee Ave for an house search. We reached 31 Chai Chee Ave at about 1425 hrs and left at about 1442 hrs to Tengah Air Base Medical Centre for FFI. We were unable to conduct a house search then because the serviceman's father was not in the house and the serviceman did not have his house key.

6. I wish to state that we reached Tengah Air Base Medical Centre at about 1535 hrs and left at about 1625 hrs to return to MP Command and reached MP command at about 1635 hrs. After we reached MP command, 3SG Jastint, 3SG Xing Ting Kai and 3SG Zhang Qingyang escorted CPL Muhammad Ridzwan back to the Escort Processing Office (EPO). We had a AAR at about 1720hrs and moved out to refuel the Ops Vehicle at Choa Chu Kang Shell station. We returned to MP command at about 1820 hrs to 1830 hrs. I wish to state that we moved out for the 2<sup>nd</sup> house search at 1855hrs.

7. I wish to state that, I was informed about the house search on 4 Nov 17 at about 0003hrs by 3SG Jastint. He told me that 1WO Zaini tasked me to drive the team down to the accused's house to conduct the search, and 3SG Jastint also told me that he will inform me when he was done with the statement taking.

8. I wish to state that 3SG Jastint did give me warning by calling "Sir, Sir, Sir". However, I did not understand the warning given by him quickly enough. I also wish to state that, at the point of accident, My eyes felt strained.

9. The above-mentioned statement was given by me to the Investigation Officer under no inducement, threat or promise. I was given the opportunity to read the statement and add or amend any part of it. I affirm it to be true and correct. I also affirm that I will not disclose or discuss any contents of this statement to persons not authorised to receive it / connected to this case. I will keep this statement to the strictest confidence. That is all.
