Accident Sketch Plan



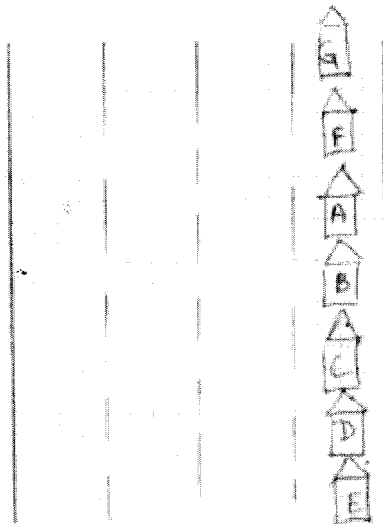
