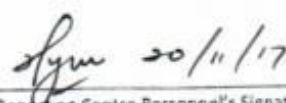
I understand, acknowledge, agree and consent that:

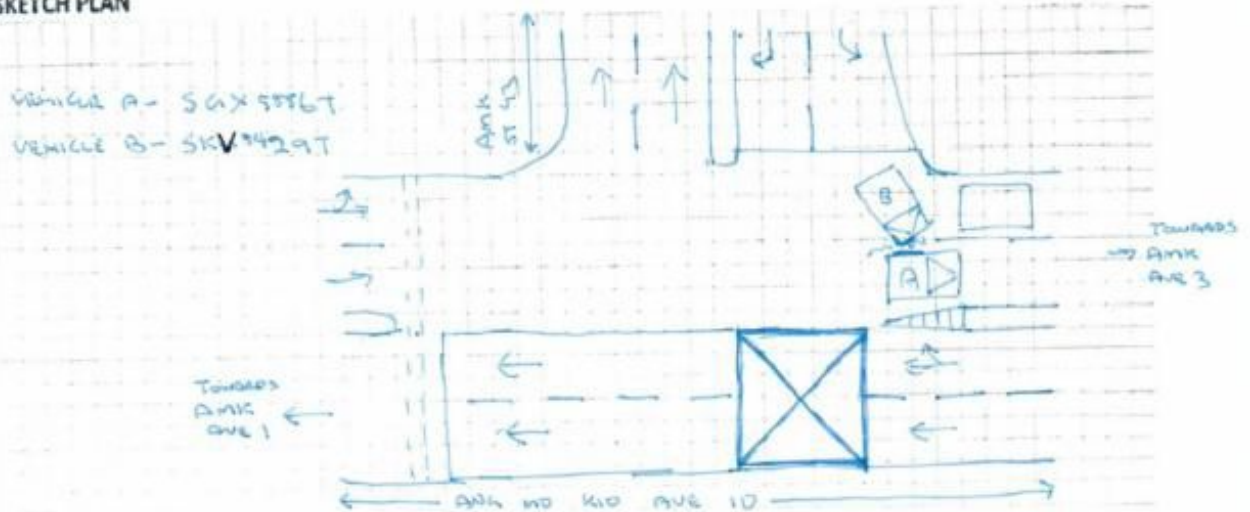

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I WAS DRIVING STRAIGHT ON THE EXTREME RIGHT LANE OF ANG MO KIO AVE 10 TOWARDS ANG MO KIO AVE 3.

WHILE DRIVING STRAIGHT AHEAD, PASSING THE T-JUNCTION OF (ANG MO KIO ST 43 / ANG MO KIO AVE 10), SUDDENLY I FELT A IMPACT COMING FROM THE LEFT SIDE OF MY VEHICLE.

ALIGHTED FROM MY VEHICLE AND OBSERVED A VEHICLE BAITING (SKV 5429T) HAD COLLIDED TO THE LEFT SIDE OF MY VEHICLE WHILE TURNING OUT FROM ANG MO KIO STREET 43.
