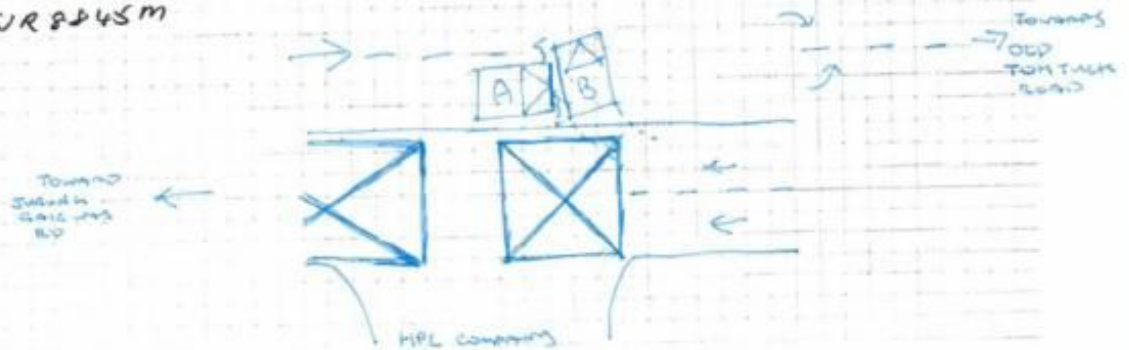

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I WAS DRIVING ALONG TON GUAN ROAD EAST TOWARDS OLD TON TACK ROAD. I WAS ON THE RIGHT LANE.
TRAVELLING STRAIGHT AND COMING TO THE JUNCTION OF (TON GUAN RD EAST / TON GUAN ROAD WEST), AS IT WAS MY RIGHT OF WAY, AND I PROCEEDED TO DRIVE ON AHEAD. SUDDENLY A VEHICLE FROM THE OPPOSITE DIRECTION JUST TURN AND I TRIED TO HORN AND JAMMED BRAKE BUT COULDN'T STOP IN TIME AND HIT ONTO THE LEFT SIDE PORTION OF THE VEHICLE.
ALIGHTED FROM MY VEHICLE AND REALIZED A VEHICLE DRIVING (SSR 8845M) DIDN'T STOP AT THE TURNING JUNCTION TO GIVE WAY TO ME AND JUST TURNED INTO THE SMALL ROAD THAT CAUSES ME COULDN'T STOP IN TIME AND HIT ONTO THE LEFT SIDE PORTION OF VEHICLE (SSR 8845M).
