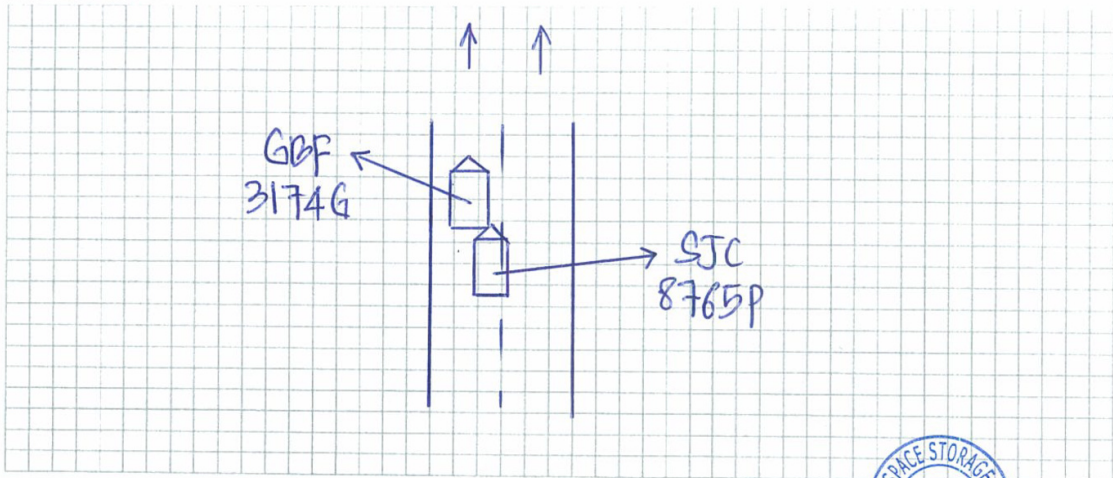

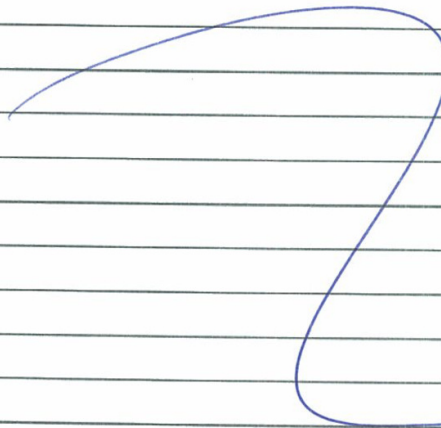
SKETCH PLAN
