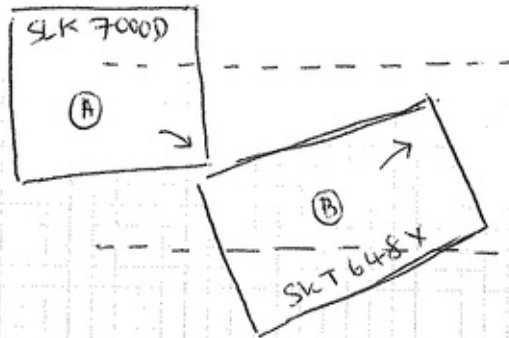

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 27 Oct 2017, I was driving along Orchard Blvd Rd towards Orchard Ion before Orchard Turn at about 6:22pm. I was on the extreme right lane waiting for the traffic to turn green. Once it had turned green, I proceeded forward and noted that there was a stationary truck at the next junction (about 50m ahead). I signaled and checked my blind spot ~~at~~ spot before filtering the lane. The traffic on my left was also slow due to the heavy traffic conditions at that time. I managed to filter into the left lane, however, at I was completing the filter, at about 80% done, I felt a ~~bump~~ bump or noise from the rear of my car. I did not hear any honk or warning from other vehicle. I immediately move to the side of the road to inspect my car. One driver, Ng Jun Yong, got out of his black Toyota vehicle (SLK 7000D) and claimed he was involved in the accident. As I am cleared that I have ensured sufficient space before I filter, I told him that I would just claim insurance. No injury from both parties. There are scratches at the left back. I have camera video.

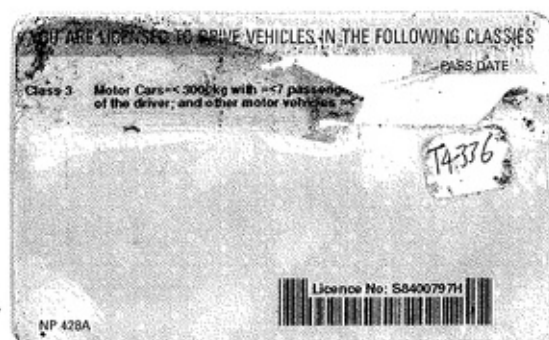
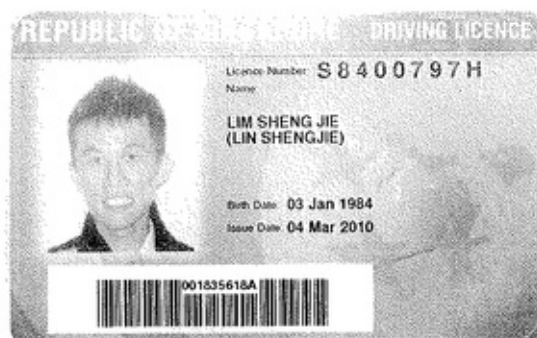
