

Brief Details.

On 13/11/2017 at about 1135hrs, I was driving my vehicle; SLS4728R along 3E Pasir Panjang Road at Mapletree.

While going up slope, there was a taxi; SHC8862R driven by Tan Inn Ting; S1614877F in front of my vehicle. As he stopped in the middle of the slope, I also stopped behind him. However, soon after his vehicle; SHC8862R started rolling backwards. I started honking at him, however as it was too sudden I was unable to reverse.

After the accident, we both exited our vehicles and exchanged particulars with one another. However, he offered to settle outside but he said the claims would be "50 - 50". As my vehicle belongs to Grab, I had to make a report to them. At the later part of the day, his brother called me on behalf of Tan Inn Ting and told me not to report and settle it outside. However, I have already made the report.

I wish to state that there was no dispute nor any physical altercations between us. I also wish to state that the vehicle; SHC8862R rolled back and I was taken aback by the incident thus unable to react fast enough. I wish to state that there is an in-car camera in my vehicle.




