

- I am the owner and driver of my car, a grey Audi RS6, SJV 3186 T. I had parked my car at the Public Carpark at ABC Brickworks Market on 14 November 2017 at around 8.00 pm at lot no. 233 and proceeded to ABC Brickworks Market to have dinner.
- I returned to the carpark at around 8.50 pm after my dinner. As I was walking towards my car, I saw that another vehicle, SHB 6389 J, a white Mercedes LimoCab Taxi had parked next to my car, on the right in lot no. 232. The said white Mercedes LimoCab Taxi was driving out of lot no. 232.
- 3. I saw that the white Mercedes LimoCab Taxi was making a left turn as it was moving out of lot no. 232. However, the white Mercedes LimoCab Taxi had turned left too soon. It turned left without having sufficiently exited lot no. 232, such that the driver of the white Mercedes LimoCab Taxi did not provide for enough clearance between his white Mercedes LimoCab Taxi and my car.
- 4. As a result, the left body and left rear wheel of the white Mercedes LimoCab Taxi scraped against the front right portion of my car. There was a loud grinding and cracking sound and I could hear the body work and bumper of my car being damaged. My car was stationary throughout the incident.
- 5. The white Mercedes LimoCab Taxi parked in another lot (lot no. 153) and I spoke with the driver, Mr Daniel Lim Lay Thiam. Mr Lim acknowledged that the incident

was entirely his fault and he apologised for it. We exchanged particulars, including our contact numbers and taking pictures of each other's NRIC.
