ACCIDENT INVOLVING VEHICLES SKG 479K(OI) AND SHC 5903B(TP) ON 21/11/2017

We refer to the above matter.

TP reported that he was travelling straight within his lane when OI swerved into his lane and collided onto his left side front portion. No photos or CCTV footage provided by TP till date.

OI reported that he was travelling within his lane when TP collided onto his right side portion of his vehicle. Enclosed copy of OI CCTV footage as attached for your easy review.

Based on OI CCTV footage, after review, we observed OI vehicle was travelling within his lane when TP vehicle encroached into his lane which resulted in the collision.

We had spoken to the Insured where he confirmed that at the material time, he was travelling at the said location as reported when TP vehicle encroached into his lane and collided onto the right portion of his vehicle. OI further mentioned that his PD recovery claim against TP is still in the process and will revert for any update.

Based on the OI CCTV footage and accident scenario, we are of the view that OI version is more credible.

As such, we intend to reject the TP claim.
