SKETCH PLAN




I understand, acknowledge, agree and consent that:

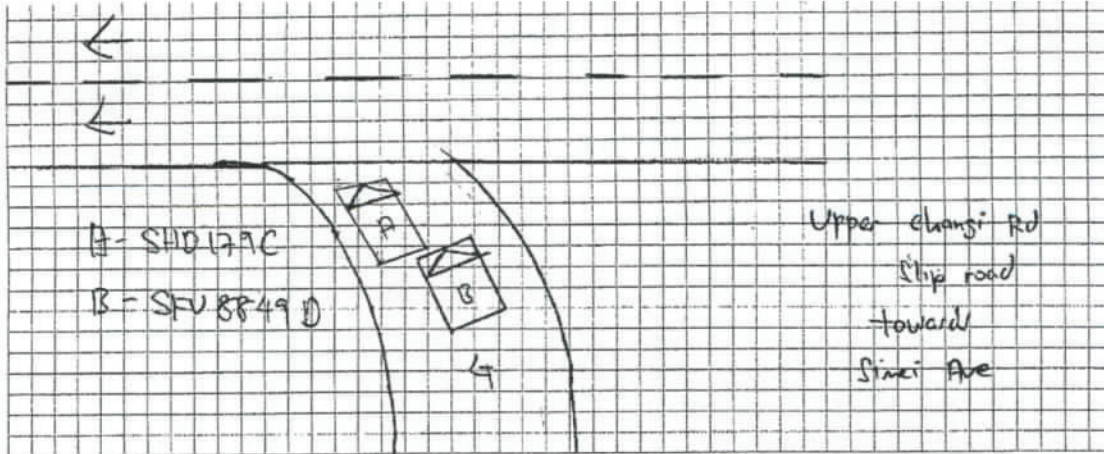

Sketch Plan #2 Pg. 1




