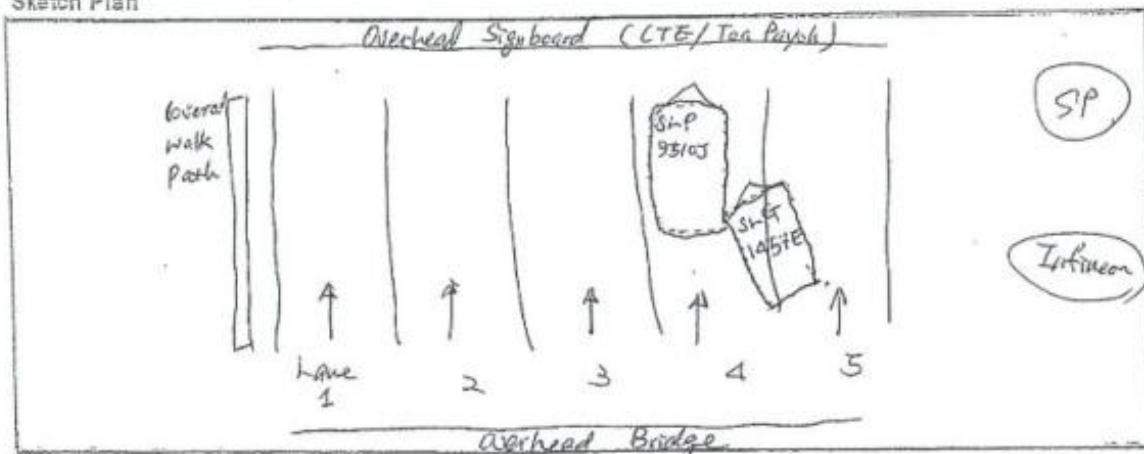

Describe Circumstances of the Accident

On 22 November 2017 at 5:25 p.m., I was driving my car (Toyota Atrix Vehicle SLP 9510J) along PIE Lane 3 in the direction of Tuas.

At a point, not far from the overhead signboard (CTE/Tas Payoh), I checked my car rear mirror as well as the right side mirror. There was no car immediately behind or in the vicinity on the right lane (Lane 4).

My right turning indicator was on and I started to change gradually from Lane 3 to Lane 4. My car, SLP 9510J, had fully entered Lane 4 when vehicle SLG 1457E suddenly moved from Lane 5 and hit my right rear wheel mud guard, resulting in scratches and damage to my car rear body and rear door (right side).

Damage to SLG 1457E was on the left hand side front bumper.
