ACCIDENT INVOLVING VEHICLES SLB 1736B (OI) AND SHA 7546X (TP) ON 23/11/2017

We refer to the above matter.

It was reported that the Insured vehicle was moving out from c/p lot when the collision happened.

We had spoken to the Insured Driver Mr Nasaruddin and was informed of the TP claim and liability issues on 25/01/2018. **A letter was sent out to the Insured to informed about the TP claim and liability. No feedback from OI/OID till date.**

Meanwhile, we had requested for evidence from the claimant but they refused to provide any as the scenario falls under BOLA 24. Please see attached email.

In view of the above, we are of the view that liability is not to our Insured's favour and the damages sustained to TP vehicle were consistent to the nature of the accident.
