Brief Details.

ON 18/11/2017 AT ABOUT 1035HRS, I WAS RIDING MY MOTORCYCLE (REGN NO. FX1154 K) ALONG BUKIT MERAH CENTRAL TOWARDS HENDERSON ROAD, IN FRONT OF ONE CONNECTION BUILDING. AT THAT POINT OF TIME, A CAR (REGN NO. SLC 8360 A) WAS IN FRONT OF ME AT ABOUT 02 CAR LENGTH AWAY. AS I RIDE ALONG, THE CAR INFRONT SUDDENLY MADE A SUDDEN U TURN. THE CAR WAS HALF WAY THROUGH THE U TURN HOWEVER, I APPLIED EMERGENCY BRAKE HOWEVER MY MOTORCYCLE SKIDDED AND COLLIDED INTO THE RIGHT SIDE OF THE CAR'S REAR BUMPER.

THE IMPACT CAUSED ME TO FLUNG OFF MY MOTORCYCLE. THE DRIVER PARKED HIS CAR AND IMMEDIATELY CAME OUT TO ASSIST ME. I INFORMED MY FRIEND WHO CAME DOWN TO ASSIST AND CALLED AMBULANCE HOWEVER I WAS NOT CONVEYED. I WAS WORKING DURING THE TIME OF ACCIDENT. I ALSO GOT 03 DAYS MC FROM HL CLINIC (MC/153412).
