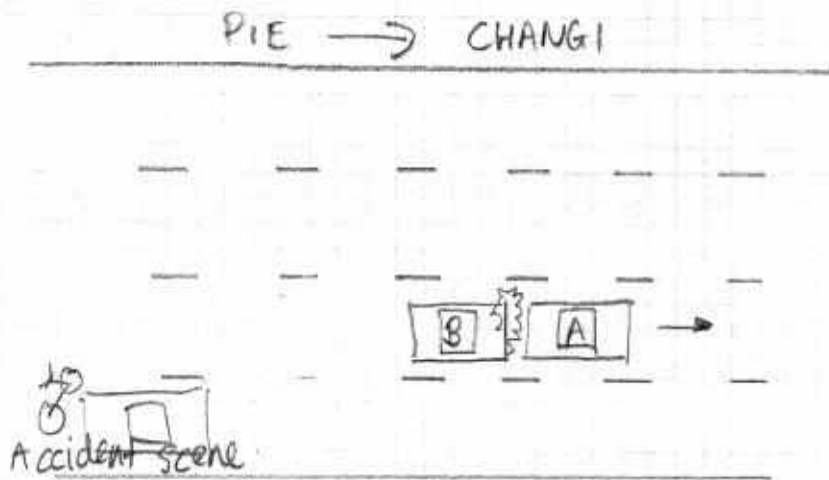

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

The incident happened on Saturday 25 November 2017 at about 7pm. I was driving along PIE towards Changi on the 2nd lane at a speed of about 70km/h. I was about 4 to 5 car lengths away from the car in front, a Mazda 3 plate SJN 9149D. The car in front suddenly jammed brake to a halt. I did my emergency braking but did not manage to stop in time. We got out of the car and asked if anyone was injured and both agreed that the passengers and drivers from both vehicles was ok. Pictures were taken on the scene and particulars were exchanged. The road condition on that day was wet because it was raining. The driver of the Mazda 3 did not wait longer and asked to leave the scene as he was in a rush to leave. We agreed to private settle. We met up on 27 November at his workshop to settle but the quotation was unreasonable, \$1200. We wanted to get a second quotation from my own workshop but he refused and insisted on doing it at his workshop. The \$1200 was quoted to change the entire bumper, licence plate and respray the bumper. There was an accident in the 1st lane involving a taxi, motorcycle and a few cars.


