2 (a) **Case: IAFP-IB-20171114-Mechanical Inspection of vehicle, Motor Van GBD8149H & Motorcycle FBH9470B (TP/IP/59635/2017)**

On 4 November 2017 at about 0531hrs, above-mentioned motor van was travelling straight on lane 3 of 5 lanes when out of a sudden, he felt an impact from the rear by the above-mentioned motorcycle. As a result, the rider of motorcycle was unconscious and was conveyed to Tan Tock Seng Hospital by ambulance. However on the same day at about 0645hrs, the rider succumbed to his injuries and he was pronounced dead.

**FBH9470B:** Rider (deceased)

3 (b) **Case: IAFP-IB-20171114-Mechanical Inspection of vehicle, Motor Van GW5055E & Pedal Cyclist (TP/IP/60517/2017)**

On 8 November 2017 at about 1421hrs, above-mentioned motor van was travelling straight on lane 2 of 3 lanes when out of a sudden, the pedal cyclist who was on lane 3 swerved to the right and encroached into the motor van's path. As such, the motor van collided into the pedal cyclist. As a result, the pedal cyclist was unconscious and was conveyed to Changi General Hospital by ambulance. However on 10 November 2017 at about 0540hrs, the pedal cyclist was certified to be brain dead and he was pronounced dead.

**Bicycle:** Pedal Cyclist (deceased)

4 (c) **Case: IAFP-IB-20171113-Mechanical Inspection of vehicle, Motor Car SLA8948R (TP/IP/42119/2017)**

On 10 August 2017 at about 1904hrs, above-mentioned motor car was travelling straight on lane 1 of 2 lanes when out of a sudden, an unknown pedestrian jay-walked ahead of him from his right to left side. Driver claimed that he applied brake but to no avail, collided into the said pedestrian. As a result, the pedestrian was unconscious and was conveyed to Changi General Hospital by ambulance. However on 11 August 2017 at about 0050hrs, the pillion was pronounced dead.
