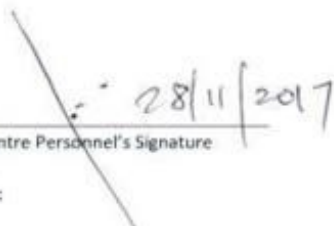

 - (ii) for complying with requirements under any regulations, laws or court orders.

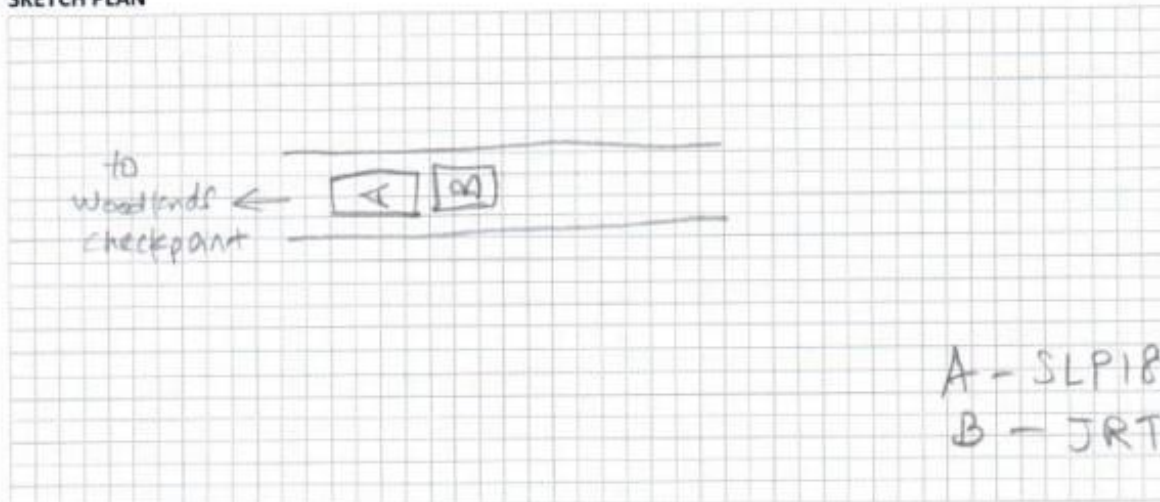

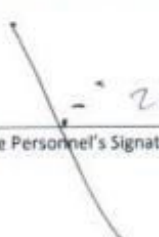
Vehicle A is waiting at a queue to the Woodlands checkpoint when vehicle B came from behind and hit vehicle A at the back.
