FACTS OF CASE:

I am the above mentioned person, owner and driver of
 Velina SLH 1200Y.

On 30/11/2017 @ 0320w, I was driving my vehicle along
 Ang Mo Kio Ave 10 towards Ang Mo Kio Ave 3. I was alone
 and heading home at B1427 Ang Mo Kio. I had come
 from Gaylan Lorong 27A at a copheshop where my friend
 was selling fishball noodle. I was there for approximately
 about 1 to 2 hours. During this time, I did not consume
 alcohol.

After exiting CTB (AMK), I took the route of
 AMK Ave 1 and made a right turn into AMK 10, heading
 to my home.

As I was driving along AMK 10, I smelt strong smell
 coming from the inside of the car. I looked down and
 bend my body towards the left side of the car to see if I could
 see what was wrong. The next thing I know, the
 front of my vehicle mounted the centre divider road curb.
 I think this could be due to me slightly pulling the
 steering wheel when I had bend forward.

My vehicle stopped on the centre divider curb and I could
 see flames coming from the left side of the front bonnet.

STATEMENT

I immediately tried to open the driver's door to alight however the door was stuck and I had to use my ~~leg~~ leg to kick the door open. I finally managed to alight and by this time, the front of my vehicle was already ~~burst~~ engulfed in flames. I was in a dazed and remember that a ~~passing~~ passerby had called for Police. As I did not know what to do and I could not help ~~if~~ even if I knew what to do (no fire extinguisher), I had left the scene. I ~~was~~ have called my friend who was nearby to come and fetch me home. The next day, I went to ANK NPC to lodge a Police report about the incident. I was informed by the Police officers that my vehicle was towed to Traffic Police compound. I subsequently received a call from Traffic Police investigation officers and I went to Traffic Police to ~~lodge~~ record a statement. I was summoned for the accident (charging the KVB) and paid the fine of \$200. My vehicle was eventually towed to ~~the~~ Ah Lim Motor for insurance claim.

I bought this vehicle about 1 year plus ago in 2016. I am the only driver and to ~~be~~ the best of my recollection, there has not been any mechanical or electrical problem with this vehicle. I regularly serviced this vehicle in August 2017. I do not have a regular place where I would go for servicing. All documents relating to the servicing and the vehicle were kept in the vehicle and destroyed by the fire. After ~~parting~~ possession, I had added 2 amplifiers and a ~~work~~ to my vehicle. This was done ~~some~~ soon after taking the vehicle. However I cannot recall the exact date. I wish to state that at the material time, I did not consume ~~the~~ alcohol or medication.
